

GHG-Emissions: Targets and Trends


Germany's emissions target under the EU BSA: -21% Demonstrable progress until 2004:

-17.4% (w/o LULUCF) or -18.5% (with LULUCF)



15/CMP.1, Annex – Para 24

(a) Progressive reduction of market imperfections, fiscal incentives, subsidies etc. in all GHG-emitting sectors

- Systematic compilation of measures in comprehensive National Climate Protection Programmes (2000 & 2005),
- Reporting to "IMA CO₂" (Interministerial Working Group CO₂-Reduction) in periodic intervals
- Other: e.g. deregulation of electricity market
- $\rightarrow\,$ Lead of BMU with involvement of BMWi, and BMF

(b) Removing subsidies for environmentally unsound technologies
→ BMU, BMWi, BMF, other Ministries & Agencies



15/CMP.1, Annex – Para 24

- (c) Cooperating with developing countries on non-energy uses of fossil fuels
- (d) Cooperation in development, diffusion and transfer of advanced fossil-fuel technologies (including CCS)
- (e) Strengthening capacity of Non-Annex 1 for improving efficiency
- (f) Assist in diversification of economies
- \rightarrow Many cross-cutting, overlapping issues.
- \rightarrow Lead for all "co-operation issues" at BMZ
- → Also private sector involvement essential (e.g. planned CCS-activities by utilities, CDM)

CDM/JI Activities - Overview

CDM is an instrument to foster investments and transfer of energy efficient technologies and processes

Germany: positive attitude towards the flexible mechanisms, although it is not intend to use CERs/ERUs for compliance in CP1

Comprehensive National Climate Protection Programme

No federal procurement programme for CERs/ERUs

Support of KfW-Fond

Financial contribution of ~ 10 Million EUR

Private activities

- Demand caused by EU-ETS, strongly increasing since 2005
- Support by German Government
 - Administration and legal framework (incl. MoUs)
 - CDM Initiative announced by Environment Minister Gabriel at CMP 1

German CDM/JI Project Activities

Current project activities in the **DEHSt approval pipeline** (active applications plus approved projects):

- 13 CDM project activities (out of which 3 approved; 2 registered at UNFCCC)
- 49 JI project activities in Germany
- 7 JI project activities in other countries

MoU with Mexico and Egypt, numerous others in preparation

Plus

- Numerous pending CDM/JI poject ideas which have not yet applied for approval/authorisation ("Pre-check status") – in total approx. 100 projects
- Several project activities with participation of German companies, for which approval has been given by other Annex-I countries.
