Upcoming negotiations at COP 17/CMP 7 in Durban, November/December 2011

Negotiations on the NWP under the Subsidiary Body for Scientific and Technological Advice (SBSTA)

Under the NWP, Parties will work towards agreeing on work areas and activities for the next phase of the programme. New mandated documents as well as new knowledge products as detailed in this eUpdate will be also be considered, including:

New [publications and knowledge products](#) are detailed below.

Joint SBSTA/SBI in-session workshop

A [joint SBSTA/SBI in-session workshop](#) is currently scheduled to take place on 30 November 2011, to consider outcomes of the NWP, and highlight the scientific, technical and socio-economic aspects of impacts, vulnerability and adaptation to climate change most relevant to the SBI.

NWP Focal Point Forum

The 5th NWP Focal Point Forum will be held on 29 November, 2011. This year the Focal Point Forum will include an interactive format, focussing on coordinating efforts, and collaborating to advance adaptation actions in relation to the NWP. Thematic discussions based around the following themes will be held towards developing specific outcomes: making use of strategic communication for adaptation; technical support for national adaptation plans; and, applying monitoring and evaluation approaches: experimentation and shared learning.

Related adaptation negotiations in Durban

COP17 will see progress on related adaptation items, as outlined below. Parties are expected to operationalize the Cancun Adaptation Framework, including

- Elaborating modalities and guidelines for formulating and implementing national adaptation programmes (NAPs);
- Further developing the Loss and Damage work programme, including by agreeing on activities to be undertaken next year;
- Further elaborating on modalities and activities for the Adaptation Committee; and,
- Electing members to the Committee so that it can start its work in assisting Parties on adaptation in early 2012.

Parties will also consider progress on implementing interim activities mandated under decision 1/CP.10 at SBI 33, including the report of the [workshop on risk management approaches](#) which took place in Lima, Peru, 10–12 October, with a view to recommending a draft decision for adoption by the COP.

In relation to least developed countries (LDC) and National Adaptation Programmes of Action (NAPA), COP17 will mark 10 years of the LDC work programme and NAPA activities. The LEG will showcase milestones achieved over the past 10 years, and Parties will discuss the work of the group for 2012, agreeing on activities related to LDCs and NAPAs.

Parties will consider funding of climate observations, under the SBI agenda item on the Financial mechanism of the Convention. The secretariat has compiled information submitted by Parties on support provided to developing countries and activities undertaken, to strengthen existing systematic observation and monitoring networks and, where needed, to establish new ones ([FCCC/SBI/2011/INF.10](#)).

Progress made in implementing activities under the NWP

The recent [NWP Progress Report](#) provides an overview of the progress made in implementing activities under the NWP since the thirty-fourth session of the SBSTA. It describes the continued engagement of organizations, institutions, experts, communities and the private sector in the activities of the NWP, as well as the progress made in implementing the interim activities mandated by the SBSTA at its thirty-fourth session. The report further provides information on the dissemination of outputs produced under the programme and on collaborations that have been catalysed between NWP partner organizations and Parties. It concludes with a brief overview of possible next steps.

New NWP knowledge products

The UNFCCC secretariat is proud to announce the publication of five new knowledge products! These publications are available electronically as well as in print.

Assessing climate change impacts and vulnerability. making informed adaptation decisions. Highlights of the contribution of the Nairobi work programme

The final version of this publication is now available. This publication highlights the important contribution that the NWP has made to advancing work related to the four main components of climate change adaptation: 1) adaptation assessment, 2) planning, 3) implementation, and 4) monitoring and evaluation, including stakeholder engagement and knowledge management. This publication draws from technical and workshop reports, synthesis reports and other knowledge products, as well as Action Pledges and updates contributed by NWP partners. A comprehensive series of case studies and additional resources is included, drawing from activities that have been catalysed or illuminated under the NWP, to easily provide adaptation stakeholders with useful information and examples.

Assessing the costs and benefits of adaptation options - An overview of approaches

This publication elaborates on the role and purpose of assessing the costs and benefits of adaptation options in the adaptation process. It explains the most commonly used assessment approaches, including cost-benefit analysis, cost-effectiveness analysis and multi-criteria analysis, and introduces a range of key methodological issues. Examples, lessons learned and good practices are provided, along with a bibliography of useful resources and references.

Practical business cases and examples of products and services - an online database

While climate change poses a number of risks to vulnerable communities and businesses around the world, many opportunities are unfolding for private companies to implement actions towards reducing risks to their business operations, as well as to invest in adaptation action in vulnerable regions in a sustainable and profitable manner. This online database of case studies has been developed under the NWP Private Sector Initiative, and features good practices and profitable climate change adaptation activities being undertaken by private companies (sometimes in partnership with NGOs or the public sector) from a wide range of regions and sectors. The first part of the project will be made available before the end of 2011 on [<unfccc.int>](http://unfccc.int).

Ecosystem-based adaptation case studies - An online database

This database provides case studies of ecosystem-based adaptation approaches across several sectors, including livelihood sustenance and food security, sustainable water management, disaster risk reduction and biodiversity conservation. The cases in this database supplement the aforementioned “Ecosystem-based approaches to adaptation: compilation of information” [UNFCCC/SBSTA/2011/INF.8](#).

Adaptation calendar 2012: Showcasing ecosystem-based adaptation activities
