Objective of NAP

Objectives of NAP

- *To reduce vulnerability to the impacts of climate change, by building adaptive capacity and resilience;*
- *To facilitate the integration of climate change adaptation, in a coherent manner, into relevant new and existing policies, programmes and activities, in particular development planning processes and strategies, within all relevant sectors and at different levels, as appropriate.*

NAP Context cont'd

- Tanzania decided to establish a process to formulate National Adaptation Plans (NAP) in order to address medium and long-term adaptation needs.
- A NAP Road map has been formulated
- The roadmap shows a milestone of activities and resources needed in the process
- The budget for the NAP preparation is estimated at USD 790,000.0
- It is expected that the NAP will use a comprehensive approach to address adaptation needs in the country, and will provide guidance to all government entities and all partners interested in supporting Tanzania in adaptation aspects
- The NAP Roadmap was developed using the technical guidelines developed by the LEG
- Thus the Roadmap takes into consideration all elements of the NAP technical guidelines produced by LEG

Structure of the Tanzania NAP Process and Roadmap

- ***Introduction*** – highlights general information on cc and how CC impacts affects Tanzania, instructional framework and national efforts to address cc
- ***Objectives*** – reflects that the objective is to establish a process for formulating sectoral and National Adaptation Plans for Tanzania, that will address medium and long-term adaptation needs

Structure of the NAP Process and Roadmap cont'd

- **Approach-** highlights 4 main elements essential for NAP as reflected in the LEG Technical guidelines:- *Laying the groundwork and address gaps, Preparatory elements, Implementation strategies and Reporting monitoring and review.*
- **Scope** –this ghlights timeline for the NAP activities, the geographical coverage, some essential documents to be considered, sectors to be covered, etc
- **methodological approach** – reflects methods for collection information, types of reports to be produced, costing, implementation startegies, monitoring and review review modalities

Structure of the NAP Process and Roadmap cont'd

- **Main tasks** - reflects the main tasks to be undertaken during formulation of NAPs, e.g. Assesements, stakeholder consultations, development of selection critreia, formulation of programmes
- ***Expected outputs***- reports and documents to be produced
- ***Estimates of budget*** - for the NAP process (a total of USD 789,000,000)
- ***Roadmap*** – *highlights costs and responsibilities*
- ***Annex*** – an outline of the NAP document

Proposed approach to develop NAP in Tanzania

- Use of multidisciplinary team
- Information collection (primary and secondary sources)
- Production of synthesis report based on reviews and technical reports
- Comprehensive Assessments of development needs and climate Vulnerabilities;

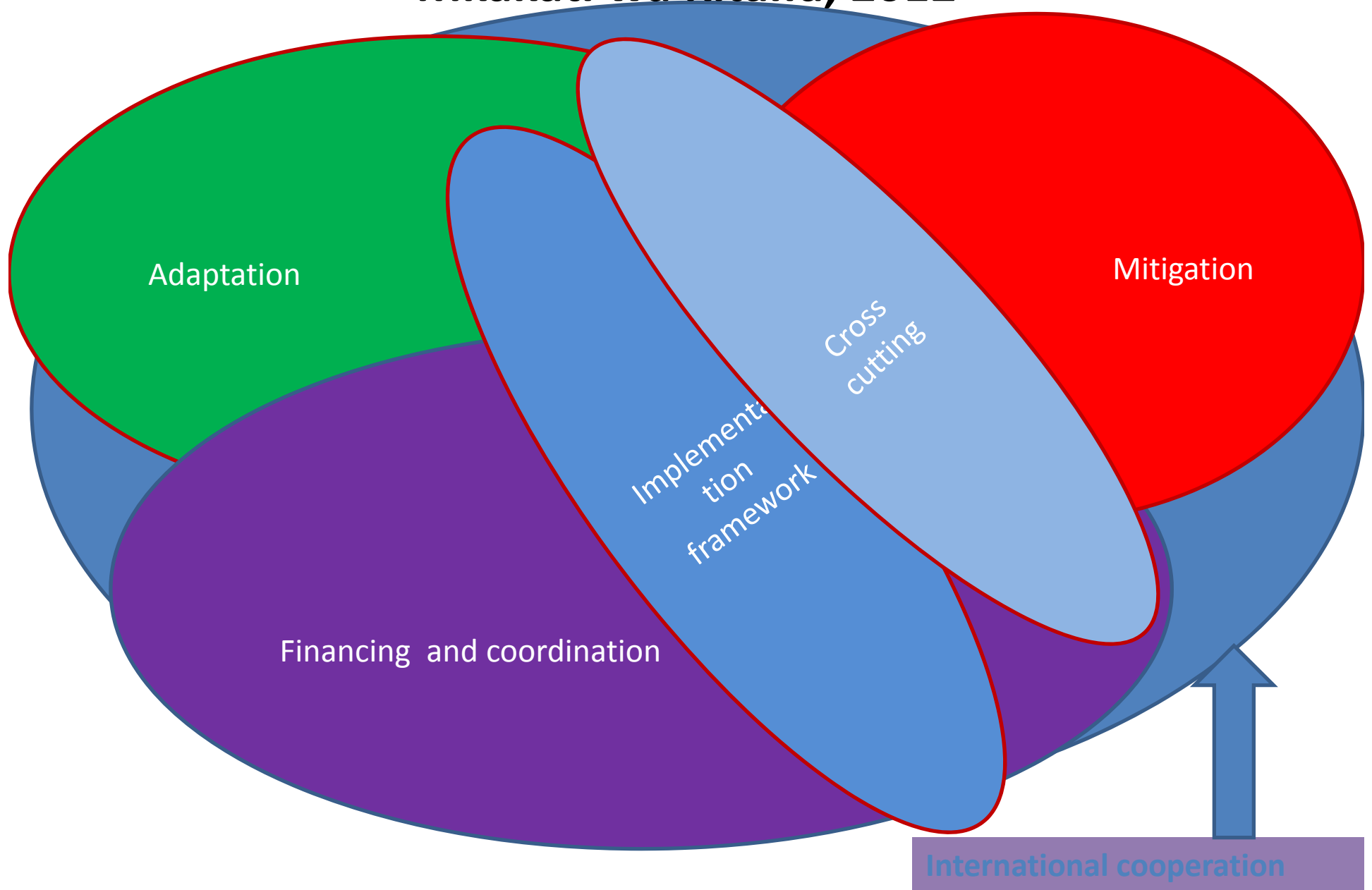
Proposed approach and tasks to develop NAP cont'd

- Development of criteria for selecting priority NAP programmes/projects;
- Assessment and development of appropriate medium- and long-term adaptation needs and propose relevant interventions including institutional and policy measures;
- Development of programme profiles

Proposed approach and tasks to develop NAP cont'd

- NAP process and Road map are prepared according to technical guidelines developed by the LEG but its in the context of the National Climate change strategy needs

Some related output so far

- One NAP stakeholders consultation for Coast and Marine was conducted 7 -8 March 2013
- Some sectoral ministries eg. Ministry of Agriculture and Food security; Ministry of Water have kicked started processes to develop their own strategy and action plans which are guided by the national processes

Challenges during the NAP process

- Lack of predictable source of financing the process and implementation (unlike the NAPA), there is no specific funding for NAP even though LDCs can access through LDCF)
- Sectoral approach if not coordinated well may lead to uncoordinated implementation of adaptation priorities
- Inadequate expertise in NAP process

Conclusion and recommendations

- NAP process is crucial for sustainable adaptation strategies
- International community should support the national initiatives to prepare and implement NAP
