Exchange rate as of 3 July:	1.00 MXN = 0.075 USD 1.00 USD = 13.3 MXN
Credit Cards:	Cash is most commonly used. However, international credit cards (Visa, MasterCard and American Express) can be used in most commercial outlets.
Language:	Spanish is the official language.
Electricity:	The voltage in Mexico is 110 Volt.
Health:	We recommend that you consult the appropriate health authorities in your country well in advance in connection with possible vaccinations and health precautions for Mexico.
