Fifth meeting of the Adaptation Committee Bonn, Germany, 5–7 March 2014

Draft plan of action of the task force on National Adaptation Plans

Recommended action by the Adaptation Committee

The AC, at its 5th meeting, will be invited to:

- Consider the activities, including the related milestones, deliverables, time frames, responsibilities and resource requirements as presented in the document;
- Further refine and prioritize these activities;
- Consider input from TF members who have not been part of the work yet;
- Agree on a draft plan of action to be presented and approved during the first meeting of the NAP task force.

Introduction

At its 4th meeting, the AC established, in accordance with its rules of procedure, a task force on NAPs to further support developing countries seeking to formulate and implement NAPs. The terms of reference of this task force were annexed to the report of the AC to COP 19, which the COP noted with appreciation.¹

The AC requested the task force to develop, with the support of the secretariat, a draft plan of action, taking into account the activities in the AC's workplan and the modalities and activities identified through the AC's work in 2013. The task force will present its draft plan of action at the 5th meeting of the AC for review and approval.

Objectives

As per the report presented to the COP, the objectives of the task force on national adaptation plans are as follows:

- (a) To serve as the panel within the AC that continuously looks at issues related to NAPs;
- (b) To liaise with LEG, upon request, in support of its work with regard to NAPs in the LDCs, ensuring consistence and supplementarity of mandates;
- (c) To identify opportunities in which activities can also be employed by non-LDCs;
- (d) To follow up on the operationalization of modalities identified for the support of non-LDCs' NAPs under the guidance of the Chair and the VC of the AC;
- (e) To report to the AC at each of its meetings on issues identified and proposed activities to support the NAP process for all eligible/interested developing countries.

Previous work of the AC on NAPs

During 2013, the AC carried out a review of initial NAP guidelines and collaboration with the LEG. The result of that work, including on the revision of the applicability of the NAPs technical guidelines to non-LDCs, can be found in documents AC/2013/15 and AC/2013/26.

Work of the LEG on NAPs and role of the AC

The LEG has focused on the technical support of the national adaptation plans process in least developing countries. The AC will continue to provide, per request and as per objective, input and

support to the LEG as it further develops NAP Central; support to the LEG to further develop methodologies for capturing and sharing best practices and lessons learned in addressing adaptation, under NAPAs, NAPs; as well as support to the LEG upon request when developing the training materials for the NAP process and the LDC work programme; regularly identify and map issues related to supporting the NAP process in all eligible developing countries and report on the mapping to every meeting of the AC; and collaborate with the LEG when and where possible.

Input from other members of the TF

There are several members of the TF not from the AC who have not engaged in the work of the AC yet (including the development of this document). Therefore, this document may need to be revised, inter alia, to include their inputs.

Draft plan of action of the task force on NAPs

The draft plan of action is contained in the annex to this document. It is structured around:

- Coherence issues related to NAPs and identifying key strategic areas;
- Technical issues related to NAPs;
- Support issues related to NAPs (finance, technology and capacity-building);
- Information sharing and outreach issues related to NAPs
