- The LDC Expert Group (LEG) mandated to explore issues related to access to funds for LDC Parties for the implementation of their NAPAs

## The National Adaptation Plans (NAP) process

- The COP provided guidance to the Global Environment Facility (GEF) to enable support by the Least Developed Countries Fund (LDCF) of activities for the *preparation of the NAP process by LDC Parties*;
- The COP also urged support for developing countries that are not LDCs, through bilateral and multilateral channels, including through the Special Climate Change Fund (SCCF), in the preparation of the NAP process.

  - The Green Climate Fund (GCF) Board



#### Outcome of the LCA

The AC to consider the establishment of an annual adaptation forum, to be held in conjunction with the sessions of the COP, to maintain a high profile for adaptation under the Convention, to raise awareness and ambition with regard to adaptation actions and to facilitate enhanced coherence of adaptation actions

#### Work of the LEG

The AC to consider the establishment of an annual adaptation forum, to be held in conjunction with the sessions of the COP, to maintain a high profile for adaptation under the Convention, to raise awareness and ambition with regard to adaptation actions and to facilitate enhanced coherence of adaptation actions



#### The TEC

- The TEC to continue to consult relevant institutional arrangements under the Convention, including the AC, SC and GCF-B, and to initiate consultations with the advisory board of the CTCN as soon as established, in order to seek their views on and coordinate the proposed modalities of the TEC on linkages with other relevant institutional arrangements under the Convention. TEC to report on the outcomes of its consultations to COP 19.
- The Advisory Board of the CTCN shall constitute the following: [...] The Chair or Vice Chair of the AC, or a member designated by the Chair or the Vice Chair

Parties and the *thematic and expert bodies under the Convention to submit to the secretariat, by 21 March 2013, their views on long-term finance*, taking into account the report on the workshops of the work programme on long-term finance, with a view to the secretariat preparing an information document for consideration by the co-chairs of the work programme

# Green Climate Fund (GCF) Board

The GCF to initiate a process to collaborate with the AC, the

TEC and other relevant thematic bodies under the

Convention, to define linkages between the Fund and these bodies, as appropriate
