4. Outcome of the work of the Ad Hoc Working Group on long-term Cooperative Action under the Convention (AWG-LCA)

#### The composition of the Adaptation Committee

The composition of the Adaptation Committee should comprise with the experts of each regional groups under UNFCCC. Considering the vulnerability of developing countries majority of experts should be selected from Non-annex I Parties.

#### Proposed linkages with other relevant institutional arrangements

This committee should be linked with regional and national centres of adaptation, Adaptation Fund and any other committees established under UNFCCC

# 5. Outcome of the work of the Ad Hoc Working Group on long-term Cooperative Action under the Convention (AWG-LCA)

As a highly vulnerable country to the impacts of Climate Change, Sri Lanka needs appropriate insurance mechanism to compensate the loss and damage due to extreme weather events such as droughts and floods, and adapting to the impacts of climate change. Therefore, risk transfer/insurance mechanism is financial contribution is necessary to strengthen this mechanism.
