ENDA Energy-Environment-Development is a member organization of the international network ENDA Tiers Monde. One of the organization's strategic areas of work includes strengthening the capacity of stakeholders in the implementation of MEAs and as such ENDA Energy has developed its interventions around the strengthening of the resilience of people and ecosystems facing the adverse effects of climate change and desertification; the organization of training sessions on climate science and tools, adaptation, mitigation, finance and technology transfer; environmental monitoring.

2. Relevant operational framework(s)

ENDA Energy has put in place a number of projects and programmes that relate directly or indirectly to loss and damage issues. These include the following:

- the C3D project: analysis of the vulnerability and adaptation planning tools
- AfricaAdapt: Support for the dissemination of good practices; Resources on adaptation including the latest Newsletter on loss and damage.
- Various projects and case studies including the coastal-eroded Rufisque and the Gambia; the case study in Niger, etc. The case studies are initiated to assess the vulnerability of the populations in the coastal region of Senegal with a view to providing possible solutions. The research is meant to contribute with knowledge and evidence to the discussions on the topic.

Ecosystem Alliance project: a broad collaboration between several NGOs in 16 countries aiming at the restoration of ecosystem services and economic power of the people.

Most importantly, ENDA Energy is now launching a major programme on loss and damage that is taking advantage of the existing projects and programmes mentioned here-above.

Firstly, the AfricaAdapt platform will be used to showcase the difficulties facing vulnerable populations in the presence of climate change. On the other hand, ENDA's Loss and Damage programme will also capitalize on all the experiences initiated at the national and continental levels. Thus, thirdly, the programme is intended to develop a strong partnership with relevant institutions at the national as well as the regional and international levels.

The operational objectives and strategies include:

- Creating strategic national and international groups to integrate losses and damages in policies and planning for climate resilient development countries, international and regional governance bodies.
- Preparing the ground for pilot projects to explore approaches to assess and treat loss and damage to collect good practices and lessons learned that can be replicated and integrated into the planning and practice.
- Launching a knowledge network on loss and damage for West and Central Africa (which will complement AfricaAdapt) and involve other organizations, researchers and practitioners as well as policy makers and decision makers in governance bodies.
