The NWP conclusions in Copenhagen

At its thirty-first session, the Subsidiary Body for Scientific and Technological Advice (SBSTA) considered progress on the implementation of the Nairobi work programme (NWP).

The SBSTA welcomed the direct engagement of a wide range of organizations, and the valuable contributions they provided toward the objectives of the NWP. The SBSTA encouraged organizations to further enhance their efforts, including through Action Pledges and by providing information to the SBSTA on the implementation of these pledges. By doing so, NWP partners can assist Parties to improve their understanding and assessment of climate change impacts and vulnerability, and to make informed decisions on practical adaptation actions and measures.

In its conclusions, which are included in the <u>report</u> of the session, the SBSTA requested the Secretariat to continue its outreach activities, including the dissemination of user-friendly knowledge products. It also reaffirmed the need to enhance the catalytic role of the NWP, and requested the Secretariat to continue its efforts in engaging a wide range of organizations. These organizations include those that work on implementing education, training and awareness-raising activities, including at the community, national and regional levels.

Other relevant negotiations in Copenhagen

The Conference of the Parties (COP) also hosted the eighth session of the Ad Hoc Working Group on Long-term Cooperative Action under the Convention (AWG-LCA), under which Parties made further progress on establishing a comprehensive adaptation framework. The conference also took note of the Copenhagen Accord, which called for enhanced action and international cooperation on adaptation, and for developed countries to provide adequate, predictable and sustainable financial resources, technology and capacity-building to support the implementation of adaptation action in developing countries.

Parties decided to extend the mandate of the AWG-LCA, and requested it to present the outcome of its work to the COP at its 16th session in Mexico. The latest adaptation text is contained in document <u>FCCC/CP/2010/2</u>, and more information on how negotiations will proceed this year can be found on the <u>UNFCCC website</u>.

Technical Workshop on

Collaboration among Regional Centres and Networks;

Apia, Samoa, 2–5 March 2010

The four day workshop on collaboration among regional centres and networks, hosted by the Government of Samoa, was attended by over 60 participants from both developing and developed country Parties, relevant organizations, regional centres and networks, communities, and experts. It was held under three work areas of the NWP, namely: 'Methods and tools', 'Data and observations', and 'Climate modelling, scenarios and downscaling'.

The workshop took stock of current collaborative efforts at the regional level to support adaptation. It provided a platform for dialogue between users and developers of methods and tools, data and observations, and climate scenarios. Participants discussed practical ways to improve support for adaptation through enhanced collaboration among regional centres and networks.

Participants also shared examples of activities on the ground in terms of collaboration among centres and networks. The Caribbean Community Climate Change Centre (CCCCC), for instance, reported on the dialogue that was initiated between 2001 and 2004 with the South Pacific Regional Environment Programme (SPREP) and the Pacific Islands Climate Change Assistance Programme (PICCAP) for collaboration on issues related to climate change. This collaboration has, amongst other outcomes, led to the successful launch of a Master's Programme in Climate Change (which is now in its 6th year).

The workshop also identified good practices, gaps and key challenges, as well as priority areas for further collaboration, including:

- Knowledge management and dissemination;
- Technical backstopping;
- Collaboration across sectors and regions.

The preliminary report of the workshop will be available shortly on the <u>NWP website</u>. The full workshop report will be made available to the SBSTA at its thirty-third session, in accordance with the mandate from SBSTA 28.

Call for Action 9

Call for Action 9 was endorsed by the SBSTA at its thirty-first session in Copenhagen in December 2009.

This new Call for Action summarizes priority actions identified at the <u>workshop</u> on increasing economic resilience to climate change and reducing reliance on vulnerable economic sectors, held in Cairo, Egypt, from 28 to 30 April 2009. The workshop was mandated under the <u>Economic Diversification</u> work area of the NWP.

The work in the area of economic diversification promotes understanding and the development and dissemination of measures, methodologies and tools aimed at increasing economic resilience and reducing reliance on vulnerable economic sectors.
