This submission is made by Arab group to reflect the group's initial reaction to the "tool" produced by the co-chairs, with the aim of closing major gabs in order for the tool to be a basis for discussions.

Section D Mitigation

- Collective Efforts, paragraph 3: This paragraph should be moved to Section A (Preamble) or Section C of Part One (General / Objective).
- Individual Efforts, paragraph 4: This paragraph should take into consideration COP
 Decision 24/CP.18 in which parties may put forward their plans in pursuit of economic
 diversification that have co-benefits in the form of emission reductions, adaptation to
 the impacts of climate change and response measures.
- Progression, paragraph 6: This should be moved to Section C of Part Two and should be comprehensive, taking into account adaptation and the means of implementation.

Part Three

 Response Measures: The concept of Response Measures is agreed to and wellestablished under the Convention, as well as the Kyoto Protocol and numerous COP decisions, and thus should be included in the Mitigation section of Part One. Paragraph 25 of Part Three should be brought back to Section D of Part One.

 is more appropriately placed into the Section I (Transparency of Action and Support) of
 Part One.
- Economic Diversification: Paragraph 56 of the Geneva Negotiation Text should be reinstated in Section E of Part One.
