## AILAC Proposed Textual Insertions Article 10 – Global Stocktake Draft Agreement

## Article 10 – Global Stocktake Original Text with Line by Line textual suggestions

- 1. The CMA shall [AILAC: periodically] take stock of the implementation of this Agreement to assess aggregate progress towards achieving the objective of the Convention [AILAC: ,and the purpose of this Agreement as set out in its Article 2,] in a comprehensive and facilitative manner. The stocktaking shall consider [AILAC:] the aggregate effect of the [AILAC: implementation of the individual] efforts by Parties, as well as assessments of the [AILAC: aggregate level of ambition communicated through the proposed nationally determined contributions for the subsequent commitment period in relation to the level of ambition needed as recommended by the] best available science, with a view to enhancing the implementation of the Agreement [AILAC: ; adaptation needs resulting from the level of implementation of mitigation efforts, and the adequacy of the mobilization and provision of means of implementation to developing countries, taking into account the aggregate level of ambition as communicated through the NDCs]; .
- 2. The CMA shall undertake its first stocktaking in [2023][2024] on the basis of the [AILAC: elements identified in Paragraph 10.1 supra, and the] modalities to be adopted by the CMA at its first session, and shall conduct stocktakings thereafter at regular intervals to be decided by the CMA.

## Draft Decision - Global Stocktake Original Text with Line by Line textual suggestions

- 60. *Decides* that the stocktaking referred to in Article 10 of the Agreement shall be designed to:
  - (a) Take into account the information on the implementation of the individual and collective efforts under the Agreement;

[AILAC (a). bis. Consider the aggregate effect of the nationally determined contributions communicated by Parties for subsequent commitment periods;

- (a). ter. Consider the state of adaptation efforts in light of mitigation trajectories;
- (a) quat. Consider the adequacy the adequacy of the mobilization and provision of means of implementation]
- (b) Be informed by the reports of the IPCC;
- (c) Take into consideration the lessons learned from the 2013–2015 review;
- 61. Requests the SBSTA to provide advice on how the assessments of the Intergovernmental Panel on Climate Change can inform the stocktaking of the implementation of the Agreement pursuant to its Article 10, paragraph 1, and to report to the IPC on this matter at its [second] [AILAC: first] session;
- 62. Also requests the IPC to develop modalities for the stocktaking, referred to in Article 10, paragraph 2, of the Agreement, and make recommendations to the CMA for consideration and adoption at its first session. The IPC should be guided by paragraph 60 above and Article 10, paragraph 1, of the Agreement, take into account the advice of the SBSTA referred to in paragraph 61 above, and consider the following when developing the modalities:
  - (a) The arrangements for the stocktaking including the institutional arrangements and the relationship with other Agreement and Convention processes and procedures;
  - (b) The operational processes and procedures, including relevant time frames;

[AILAC: b.bis The manner in which the stock take process shall serve as an input to the High Level Sessions established under Articles 4.10 and 6.12 of the Agreement]

(c) The form and nature of the outcomes of the stocktaking [AILAC: taking into account the nature of the process as described in Article 10.1 of the Agreement];
