A. DRAFT AGREEMENT

Individual efforts, differentiated efforts, progression, ambition, framing (Art 3.2, 3.3, 3.4, 3.5 and 3.18)

The spin-off group on mitigation agreed to continue Party led work on the cluster Art 3.2, 3.3, 3.4, 3.5 and 3.18

3.2 {Individual efforts}

Merger a b c: Each Party shall regularly prepare, communicate [, maintain] an NDMC* and [shall][should][other][implement][[develop] nationally determined policies, domestic laws or other measures to achieve it]

- Opt a** Each Party shall regularly prepare and communicate successive NDMCs* [and should implement]
- Opt b** Each Party shall regularly prepare, communicate, maintain and implement an NDMC*
- Opt c** Each Party shall prepare, communicate, maintain and regularly update successive NDMCs*. Each Party shall [have in place][pursue] domestic laws, policies or other measures [[designed] to [implement] [achieve] [carry out]][[that support implementation of][[in support of achieving] its NDMC*.
- Opt d** Each Party shall timely put into effect integrated components of the Convention through indigenous arrangements

- Opt i)** Nationally Determined Mitigation [Contribution][Commitment] (NDMC)
- Opt ii)** Nationally Determined Mitigation Component of the Contribution referred to in Article 2bis (NDMCC)
- Opt iii)** Mitigation Component of the [Intended] Nationally Determined Contribution (MCNDC)
- Opt iv)** INDC which can be in the form of co-benefits resulting from the Party's adaptation contributions and economic diversification plans

3.3 {Differentiated efforts}

Option 2:

- a) In accordance with Article 4, paragraph 2, of the Convention, developed country Parties and other Parties included in Annex I shall undertake quantified economy-wide absolute emission reduction and limitation commitments/targets, which are comparable, measurable, reportable and verifiable, cover all greenhouse gases and are implemented domestically without any conditions.
- b) In accordance with Article 4, paragraphs 1, 3, 4, 5 and 7, of the Convention, developing country Parties should undertake diversified enhanced mitigation actions/efforts in a measurable, reportable, and verifiable manner, in the context of sustainable development and supported and enabled by the provision of adequate finance, technology and capacity-building by developed country Parties.

Option 4

Opt a: Each Party that has previously [communicated] [implemented] absolute economy-wide emissions reduction or limitation targets should continue to do so and all Parties should aim to do so over time.

Opt b Developed country Parties [and other Parties [in a position][that determine] to do so] should take the lead in mitigation efforts, including by [communicating] [and implementing] absolute economy-wide emissions reduction [or limitation] targets and all other Parties should aim to do so over time.

[Parties may otherwise communicate quantified targets relative to business as usual, carbon intensity of gross domestic product, or other reference point, or non-economy-wide actions.]

Both for options 2 and 4: Developed country Parties should continue to take the lead.

3.3 bis {LDCs}

LDCs [and SIDS][and African states] may communicate their NDMC at their discretion, including information on strategies, plans and actions for low GHG development, reflecting their special circumstances.

3.4 and 3.5 {Progression and ambition}

Option 1

Each Party's NDMC [shall][should][will] represent a progression beyond the Party's current efforts and reflect its highest possible ambition [based on CBDRRC][and the progression and ambition of developing country Parties [shall][should][will] be supported and enabled by the provision of finance, technology development and transfer and cap building by developed country Parties over time] in the light of its national circumstances and of recommendations of science.

Option 2

Each Party's NDMC [shall][should][will] represent a progression beyond the Party's current efforts and reflect its highest possible ambition[, guided by CBDRRC [and] in light of different circumstances] *(brackets depending on placeholder in 3.2)*
