I. Opening of the meeting

- 1. The fourth meeting of the Transitional Committee (TC) for the Design of the Green Climate Fund (GCF) was held at the Cape Town International Convention Centre in Cape Town, South Africa, from 16 to 18 October 2011.

IV. Report of the Transitional Committee to the Conference of the Parties

(Agenda item 4)

- 6. The Co-Chairs introduced the draft report of the TC to the seventeenth session of the Conference of the Parties (document TC-4/2). The TC undertook a detailed review of the document, including the recommendations of the TC to the seventeenth session of the Conference of the Parties (COP 17) and the annex containing the draft governing instrument for the GCF. The TC also considered a proposal presented on behalf of the Alliance of Small Island States (AOSIS) on issues relating to the operationalization of the Green Climate Fund.
- 7. TC members offered comments on and proposed amendments to the documents. Based on these comments and proposed amendments the Co-Chairs and Vice-Chairs presented a revised draft of the report of the TC to COP 17 (TC-4/L.2).
- 7. Document TC-4/L.2 was considered by the TC on 18 October 2011. Following an exchange of views among the TC members, the TC agreed to submit the report by the TC to COP 17 for its consideration and approval, in accordance with relevant provisions of decision 1/CP.16 and its Appendix III (document TC-4/3).
