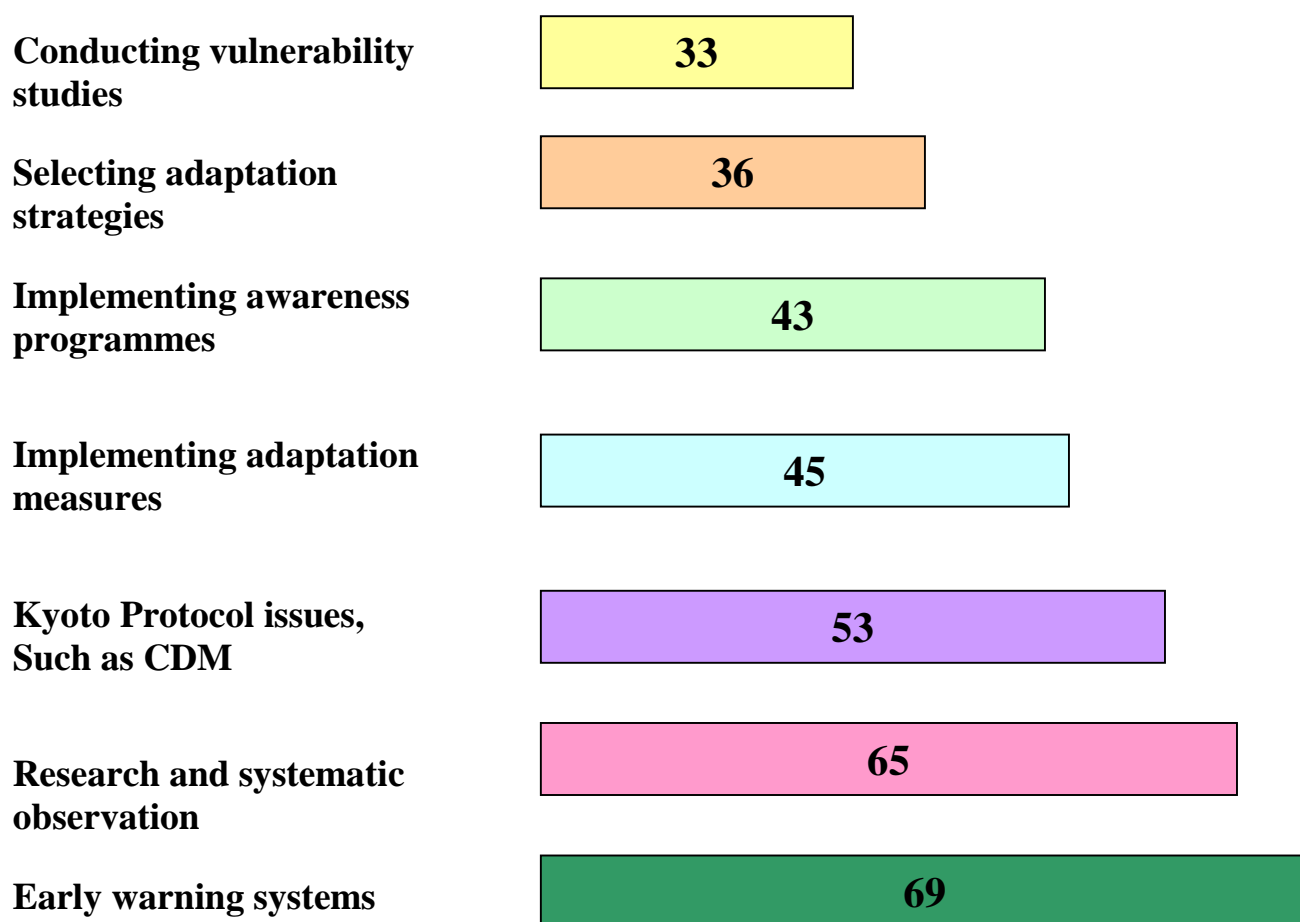

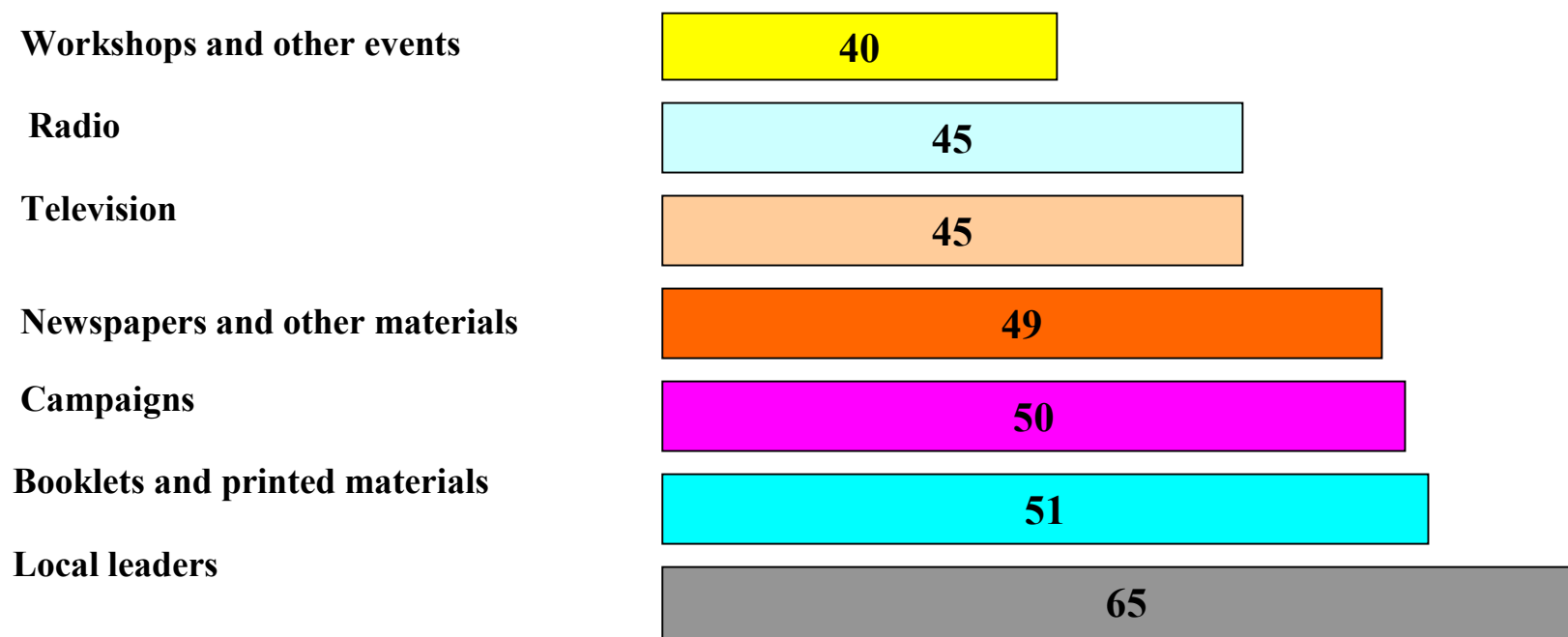

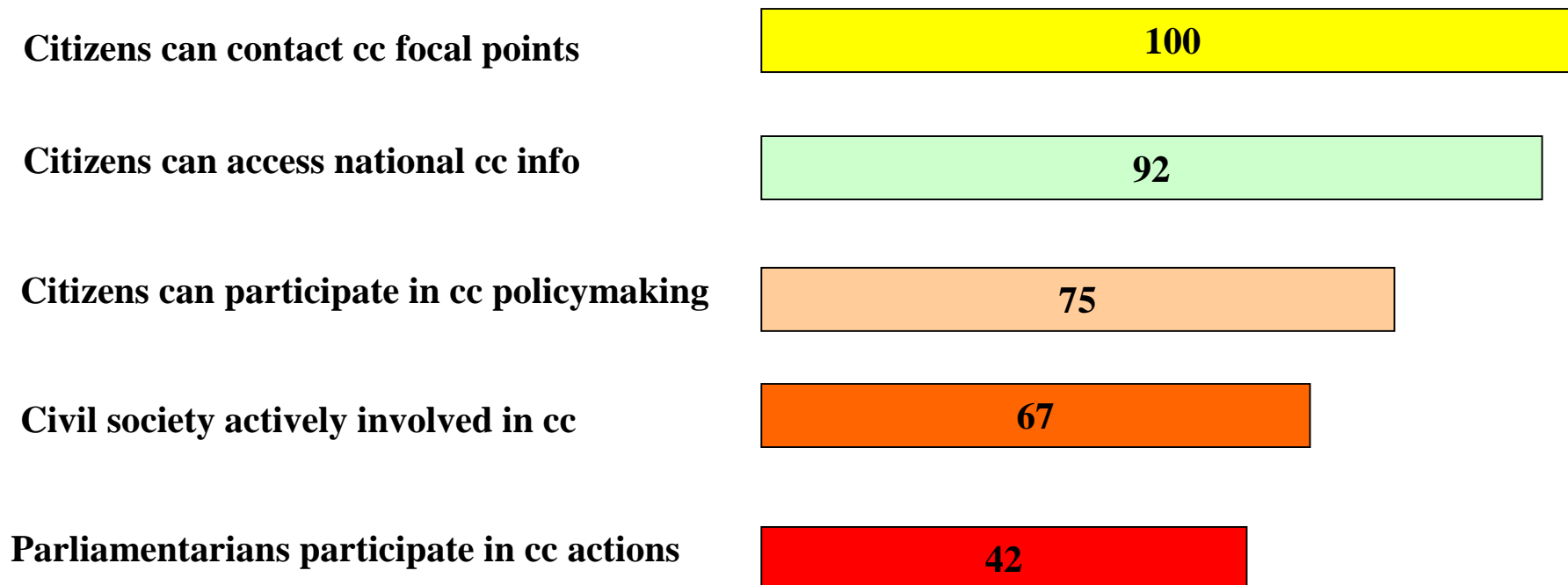

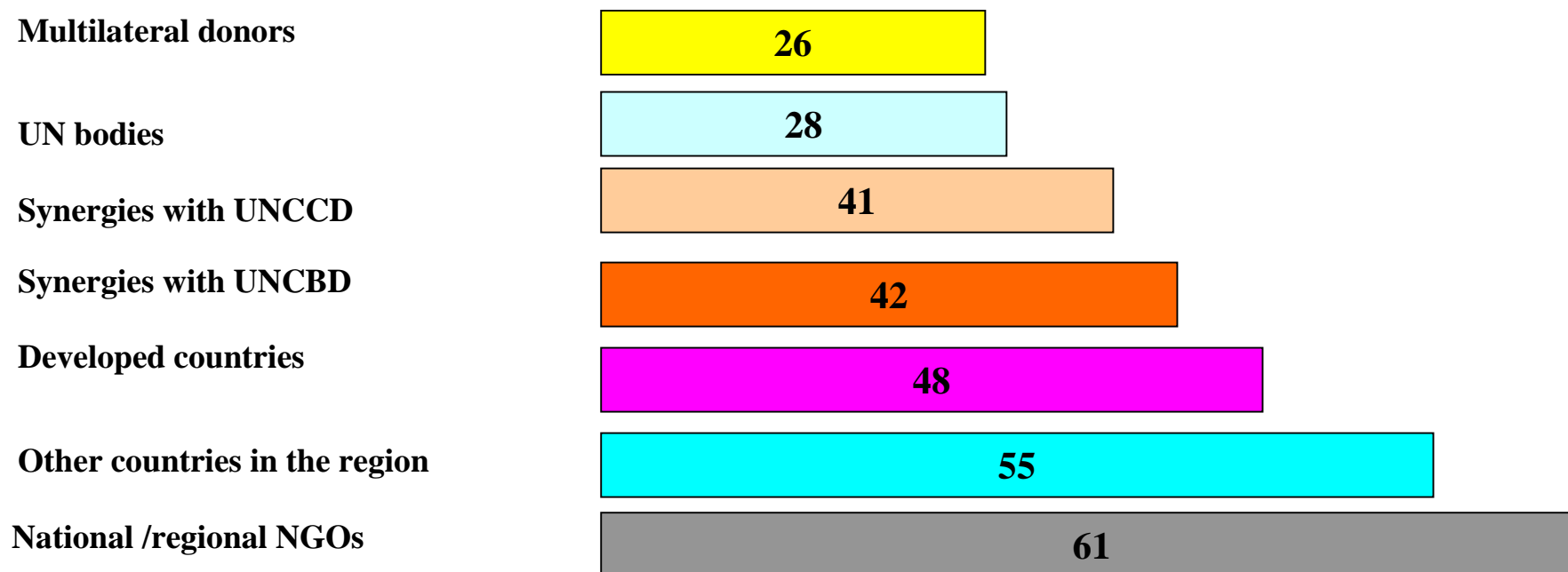
**6. PUBLIC PARTICIPATION AND ACCESS TO INFORMATION**

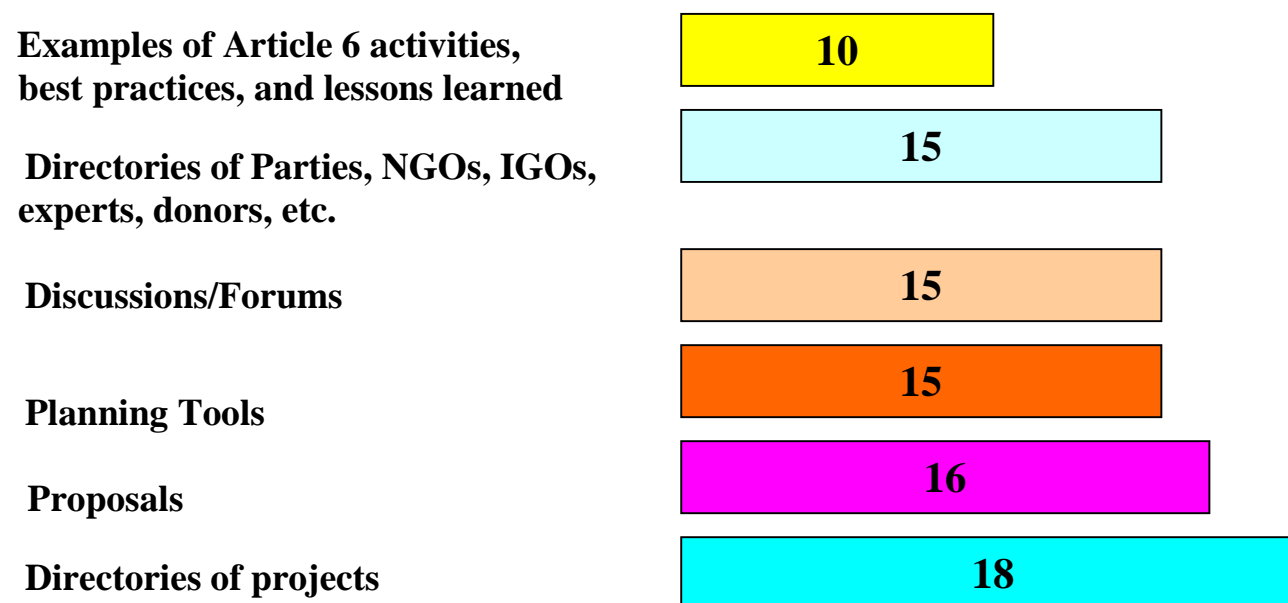
**7. POTENTIAL FOR STRENGTHENING INTERNATIONAL COOPERATION**
