	Access		<i>Invites</i> the GCF, as an operating entity of the Financial Mechanism, to provide information on how to access GCF resources, including through the Readiness and Preparatory Support programme, in French and Spanish and potentially other languages to facilitate the application process for non-Anglophone countries;	The GCF has developed materials to assist NDAs with accessing GCF resources; however, these are not available in languages other than English. Translating these resources into French and Spanish could drastically increase access without imposing a significant burden on the Secretariat.
