- What is the most efficient / effective means of achieving climate change mitigation goals?
- What are the economic impacts of particular policies in the energy and LULUCF sectors?

### **CLIMACAP: Relevance for domestic preparation** processes in Latin America

- Supporting national energy and GHG modeling being conducted by Colombia Low Carbon Development Strategy (CLCDS), a government-led initiative.
- COPPE is running an official Brazilian research project that will be used by Brazil to support its position in future negotiations approach shared in CLIMACAP.
- IPEA will improve the Brazilian LULUCF model and develop LULUCF models for Argentina, Colombia and Mexico.
- In Argentina and Mexico, FB and UNAM, supported by SEI, will improve energy and climate models covering the national energy system.
- KEY OUTPUT: PEER-REVIEWED SPECIAL ISSUE OF INTERNATIONAL JOURNAL PRIOR TO COP 20 THAT WILL OUTLINE OPPORTUNITIES, BENEFITS AND ECONOMIC TRADE-OFFS FOR LATIN AMERICA OF DIFFERENT NATIONAL AND GLOBAL CLIMATE MITIGATION PATHWAYS (IE. DIFFERENT SCENARIOS)

Project aims to increase the quality and ambition of the global negotiations through contributing to a better understanding of the implications of different low emission pathways
