16:00 – 16:15	<p>Introduction Claudio Forner (UNFCCC) – 15min <i>Introduction</i></p> <p>Political negotiations concluded with the successful adoption of the Paris Agreement in 2015. Countries are looking at identifying and implementing measures to meet the objectives of their NDCs and to create the national capacity for long-term low GHG emission and climate resilient development. Article 4 of the Paris Agreement contains provisions to guide Parties in the operationalization of the agreement’s objective departing from the identification of a global greenhouse gas emissions trajectory.</p>
16:15 – 17:00	<p>Kelly Levin (WRI) – 15min <i>Background on long term strategies</i></p> <p>Kelly Levin is a senior associate with WRI’s climate team. She oversees WRI’s pillar of work dedicated to building the capacity of governments, we well as conducting independent research on, the design and transparent tracking of climate policies and targets. She also leads WRI’s Measurement and Performance Tracking project, which works in five developing countries to assist in the enhancement of monitoring and reporting systems. She closely follows the negotiations under the UN Framework Convention on Climate Change, and analyses related emissions reduction targets and actions.</p> <p>Allan Fawcett (Environmental Protection Agency) – 15min <i>Mid-Century Strategy for Deep Decarbonisation of the United States – methodologies and conclusions</i></p> <p>Allen Fawcett is the Chief of the Environmental Protection Agency’s Climate Economics Branch, which is responsible for developing and applying EPA’s economic models for domestic and international climate change policy analyses. His recent work has focused on international climate negotiations. At EPA, Allen led the Agency’s economic analyses of the leading climate change legislative proposals in the US Congress. His presentation will focus on the methodologies used and conclusions.</p> <p>Andrea Meyer (BMUB) – 15min <i>Climate Action Plan 2050 of Germany</i></p> <p>Andrea Meyer has been a desk officer in the Federal Environment Ministry for 18 years, working on general issues of environmental protection as well as on renewable energies. Since 2012 she has worked in the unit “general questions of climate protection; Climate Action Plan”, where she was deputy head of unit and in charge of participation and dialogue processes around the Climate Action Programme 2020 and the Climate Action Plan 2050. Her background is in adult education and English; in 2013 she received an Executive Master’s on Public Administration from the Hertie School of Governance.</p>
