- Nationally Appropriate Mitigation Actions (NAMAs); and
- Measuring, Reporting and Verification (MRV) systems.










About the Partnership

 Approx. 60 participants from about 50 partner countries from Al and NAI










Global Good Practice Analysis

- In order to encourage more exchanges between peers in the partner countries the Partnership carried out an analysis of good practices in cooperation with the UNDP LECB Programme
- Based on existing LEDS, NAMA and MRV activities,
 21 good practice cases from 21 countries were selected
- The cases were analyzed in more depth with regard to their success factors and lessons learnt
- Final results will be converted into knowledge products
 and will be disseminated in June 2014 through the Partnership
 and the UNDP LECB Programme







Capacity Building



Peer-to-Peer Programme

Focus: Networking and exchange of specific experiences

Frequency: demand-driven

Participants: Representatives from 2 to 5 countries with similar interests and tasks at hand

Duration: 2 to 3 days



Technical Workshops

Focus: Intense study of a specific topic with either a technical or political focus

Frequency: 2-3 workshops

per year

Participants: representatives from 2 to 5 selected countries

in a region

Duration: 2 to 4 days



Summer Schools

Focus: Comprehensive insight into a complex topic (NAMAs/ LEDS/MRV)

Frequency: One Summer School

per year

Participants: 25 representatives

from various countries

Duration: 7 days
