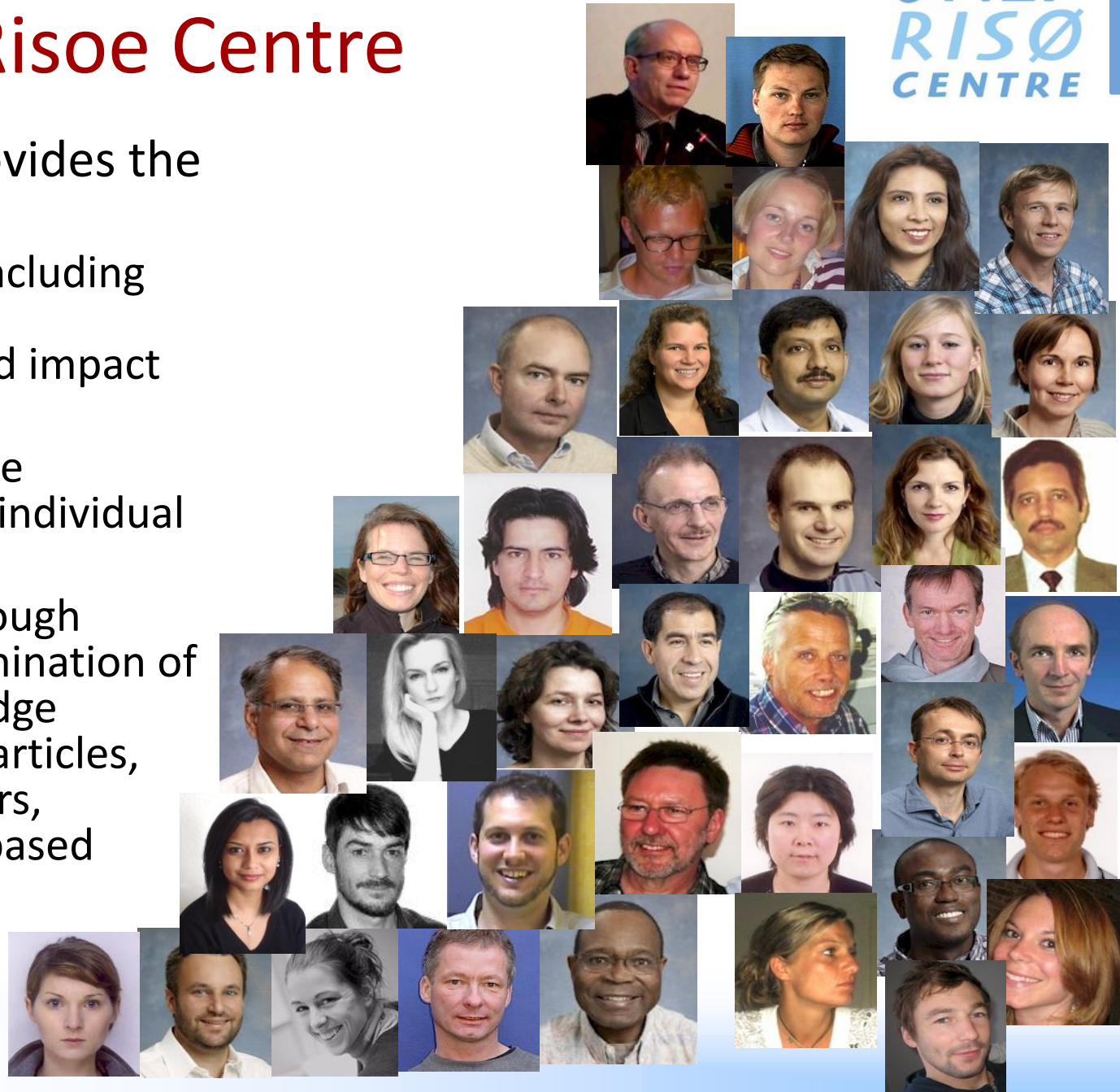

# 1. Projects

- FIRM – Facilitating Mitigation and Readiness for Mitigation
  - Danida funded: USD 6 million
  - Duration: 3 years
  - Implemented in 9 countries
- Climate Action Development Finance – NAMAs and NAPactions
  - Danida: USD 4 millions
  - Duration: 3 years
  - To be implemented in 6-8 countries

# Facilitating Implementation and Mitigation for Mitigation – FIRM

- Support to developing a sectoral or national low carbon development strategies
- Supporting national processes for development and formulation of NAMAs ready to be implemented
- Developing analytical materials and sharing project experiences and analytical results, including through regional and international networks

# Climate Action Development Finance –

## NAMAs and NAPactions

- Identifying and applying nationally appropriate models for engaging the private sector in the design, implementation and financing of concrete implementable mitigation and adaptation actions in developing countries
- NAMAs – Nationally Appropriate Mitigation Actions
- NAPactions – National Adaptation Plans



# Climate Action Development Finance – NAMAs and NAPactions

- The objective of the project is to provide assistance for private sector involvement in the design, implementation and financing of concrete implementable NAMAs and actions to support National Adaptation Plans (NAPactions) in developing countries.
- The project team will collaborate closely with applicants and have particular emphasis on identifying nationally appropriate models for engaging the private sector and private capital in support of mitigation and adaptation initiatives.

## 4. NAMAcademy

- The **NAMACADEMY** offers support for the conceptualization of NAMAs under UNFCCC.
- It provides courses and coaching to public sector officials who are responsible for formulating national or local policy initiatives that directly or indirectly reduce emission of greenhouse gasses into the atmosphere.
- First trial version on August 2013 – 65% participants from LAC region.
- We are now receiving pre-registrations for the winter course which is preliminarily scheduled for February 2014
