Status of national communications of Annex I Parties

Note by the secretariat

Information on the status of submission of fourth national communications from Parties included in Annex I to the Convention (Annex I Parties) that are also Party to the Kyoto Protocol is attached to this note. It brings to the attention of the Compliance Committee delay in submission of such communications by Annex I Parties.

Submission of national communications under the Kyoto Protocol

Fourth national communications from Annex I Parties were due to be submitted to the secretariat by 1 January 2006 (decision 4/CP.8). For Parties to the Kyoto Protocol, this is also their first national communication under the Protocol.

In accordance with the guidelines for review under Article 8 of the Kyoto Protocol, annexed to decision 22/CMP.1, delays in submitting national communications (beyond six weeks after the due date) should be brought to the attention of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol and the Compliance Committee, and made public. The guidelines also stipulate that if an Annex I Party anticipates a delay in submission, the Party should inform the secretariat before the due date.

The table below provides a summary of the status of submission of fourth national communications from Annex I Parties that are also Party to the Kyoto Protocol. As at 28 February 2006, national communications from the following Parties are still pending: Austria, Belarus, Bulgaria, Canada, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Luxembourg, New Zealand, Poland, Portugal, Romania, the Russian Federation, Slovenia, Spain, Ukraine and the United Kingdom of Great Britain and Northern Ireland. Most of these Parties have informed the secretariat of their delay in submitting their national communication.
