Annotations to the provisional agenda

1. Opening of the meeting

- 1. The question of implementation with respect to Ukraine is contained in document FCCC/ARR/2010/UKR, which was received by the Compliance Committee on 6 June 2011 under section VI, paragraph 1, and rule 10, paragraph 2. The question of implementation indicated in this document was allocated to the enforcement branch on 13 June 2011 and sent to the branch on 14 June 2011 (CC-2011-2-1/Ukraine/EB) under section VII, paragraph 1.
- 2. On 29 June 2011, the branch decided to proceed under section VII, paragraph 2, and section X, paragraph 1 (a) (CC-2011-2-2/Ukraine/EB). On 19 July 2011, the secretariat received a request for a hearing from Ukraine (CC-2011-2-4/Ukraine/EB). Ukraine made a written submission (CC-2011-2-5/Ukraine/EB) on 3 August 2011, both under section X, paragraph 1.
- 3. The branch adopted a preliminary finding of non-compliance on 25 August 2011 (CC-2011-2-6/Ukraine/EB) and agreed that in view of Ukraine's stated intention to make a further written submission within four weeks from receiving a written notification of the preliminary finding, the branch will meet from 11 to 12 October 2011 in Bonn, Germany, to adopt a final decision.
- 4. The diplomatic agent of Ukraine received the written notification of the preliminary finding on 30 August 2011. In accordance with section X, paragraph 1 (e), Ukraine may make a further written submission on or before 28 September 2011.
- 5. On 2 September 2011, Ukraine requested the postponement of the consideration by the enforcement branch of its further written submission and the adoption of a final decision, in view of the in-country review of the annual submission of Ukraine submitted in 2011, which is scheduled to take place from 10 to 15 October 2011. Ukraine indicated that the individuals who are to attend the fifteenth meeting of the enforcement branch on behalf of Ukraine need to participate in the in-country review.
- 6. After considering the request referred to in paragraph 5 above by electronic means, the branch was unable to adopt a decision in relation thereto.
