Annotations to the provisional agenda

1. Opening of the meeting

- 1. This meeting of the enforcement branch relates to the question of implementation with respect to Greece, contained in document FCCC/IRR/2007/GRC, which was received by the Compliance Committee on 31 December 2007 under section VI, paragraph 1 of the procedures and mechanisms relating to compliance under the Kyoto Protocol¹ and rule 10, paragraph 2 of the rules of procedure of the Compliance Committee.² The question of implementation indicated in this document, together with comments from Greece, was allocated to the enforcement branch on 7 January 2008 and sent to the branch on 8 January 2008 (CC-2007-1-1/Greece/EB) under section VII, paragraph 1.
- 2. On 22 January 2008, the branch decided to proceed under section VII, paragraph 2 and section X, paragraph 1(a); and it agreed to seek expert advice under section VIII, paragraph 5 and rule 21 (CC-2007-1-2/Greece/EB). Greece made a request for a hearing on 11 February 2008 (CC-2007-1-4/Greece/EB), and also made a written submission (CC-2007-1-5/Greece/EB) on 26 February 2008, both under section X, paragraph 1.

2. Adoption of the agenda

3. The branch may wish to consider the provisional agenda for adoption.

3. Organization of work

4. The branch may wish to consider the organization of its work for the session, including its schedule. It may wish to consider how best to attain its objective, as reflected in section I of the procedures and mechanisms. Among other things, the branch may wish to consider its approach to advice from experts, the presentation of the views and expert testimony or opinion by Greece, and the elaboration of its preliminary decision.

4. Advice from experts

5. The branch has invited four experts to this meeting to seek their advice (CC-2007-1-3/Greece/EB), in accordance with section VIII, paragraph 5 and rule 21. The branch may wish to consider advice in relation to document FCCC/IRR/2007/GRC, as well as advice in relation to material presented by Greece in its written submission (CC-2007-1-5/Greece/EB) and during the hearing, and in relation to the elaboration of its preliminary decision.
