Annotations to the provisional agenda

1. Opening of the meeting

- 1. This meeting of the enforcement branch relates to the questions of implementation with respect to Croatia, contained in document FCCC/IRR/2008/HRV, which were received by the Compliance Committee on 27 August 2009 under section VI, paragraph 1, of the procedures and mechanisms relating to compliance under the Kyoto Protocol¹ and rule 10, paragraph 2, of the Rules of procedure of the Compliance Committee.² The questions of implementation indicated in this document were allocated to the enforcement branch on 28 August 2009 and sent to the branch on the same day (CC-2009-1-1/Croatia/EB) under section VII, paragraph 1.
- 2. On 7 September 2009, the branch decided to proceed under section VII, paragraph 2, and section X, paragraph 1 (a) (CC-2009-1-2/Croatia/EB). Croatia made a request for a hearing on 25 September 2009 (CC-2009-1-4/Croatia/EB), and also made a written submission (CC-2009-1-5/Croatia/EB) on 9 October 2009, both under section X, paragraph 1. The branch adopted a preliminary finding of non-compliance on 13 October 2009 (CC-2009-1-6/Croatia/EB) and agreed that if Croatia makes a further written submission on or before 14 November 2009, the branch will meet to adopt a final decision. Croatia made a further written submission (CC-2009-1-7/Croatia/EB) on 12 November 2009.
