- 1. The branch may wish to review and consider the provisional agenda for adoption.

3. Organization of work

2. The branch may wish to consider the organization of its work for the meeting, including its schedule.

4. Issues arising from reports of in-depth reviews of fifth national communications and information submitted pursuant to Article 7 of the Kyoto Protocol

- 3. At its tenth meeting, the branch agreed that, where concerns with regard to potential non-compliance by a Party are raised in a report under Article 8 of the Kyoto Protocol, it will consider how the matter can be best addressed.
- 4. In particular, the branch, in considering information submitted to it under section VI, paragraph 3, of the "Procedures and mechanisms relating to compliance under the Kyoto Protocol" noted that the "Report of the in-depth review of the fifth national communication of Italy" and the "Report of the individual review of the annual submission of Canada submitted in 2010" point to potential problems in the fulfilment of these Parties' commitments, which the branch considered to engage its role under section IV, paragraph 6 (a), relating to promoting compliance and providing for early warning of potential non-compliance.
- 5. In this regard, the branch agreed to continue its consideration of information contained in all reports submitted to it under section VI, paragraph 3, including those relating to Canada and Italy, at its future meetings with a view to determining any appropriate action it may need to take under section IV, paragraph 6 (a).
- 6. At its eleventh meeting, the branch may wish to consider information contained in the reports relating to Canada and Italy mentioned in paragraph 3 above, as well as the "Report of the in-depth review of the fifth national communication of Canada", 4 which was

published after its tenth meeting, with a view to determining any appropriate action it may need to take under section IV, paragraph 6 (a). The branch may wish to agree to consider information contained in other reports submitted to it under section VI, paragraph 3, at its future meetings.
