At its ninth meeting, the plenary noted that the enforcement branch found it useful to have access to the online training modules on accounting rules and reporting and review requirements developed for expert review teams. The plenary requested the secretariat to provide all members and alternate members with access to these modules. The secretariat will provide information on possible online training modules that could be accessed by the members and alternate members in line with this request.

10. The secretariat will also provide information on the results of a survey on the level of satisfaction of the Compliance Committee of the Kyoto Protocol with the support that the secretariat provides to the Committee that was conducted in July 2011.
