# Information on the delay in submission of sixth national communications from Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol

#### Note by the secretariat

1. This note provides information on the delay in submission of sixth national communications from Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol. It includes information available as of 13 March 2014 and covers only information on Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol.

2. Through decision 9/CP.16, Parties included in Annex I to the Convention were requested to submit their sixth national communications under the Convention by 1 January 2014 in accordance with Article 12, paragraphs 1 and 2, of the Convention. In accordance with decision 7/CMP.8, Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol (Annex I Parties) shall include in their sixth national communications the necessary supplementary information required under the guidelines for reporting supplementary information under Article 7, paragraph 2, of the Kyoto Protocol, as contained in the annex to decision 15/CMP.1.

3. The "Guidelines for review under Article 8 of the Kyoto Protocol" (as contained in the annex to decision 22/CMP.1) stipulate that "If a Party included in Annex I expects difficulties with the timeliness of its national communication submission, it should inform the secretariat before the due date of the submission. If the national communication is not submitted within six weeks after the due date, the delay shall be brought to the attention of the COP/MOP and the Compliance Committee and made public" (para. 139).

4. By 14 February 2014, within six weeks after the due date, the secretariat had received sixth national communications from 34 Annex I Parties, of which 23 were submitted by due date, 1 January 2014<sup>1</sup>. As at 14 February 2014, the secretariat had not received sixth national communications from seven Annex I Parties, namely: Iceland, Italy, Ireland, Malta, Monaco, Norway and Slovenia. As at the same date, the secretariat had received ten notifications by Annex I Parties expecting difficulties with the timeliness of their national communications submission.

5. By 13 March 2014, from seven Parties mentioned in paragraph 4 above, four have provided submissions of their sixth national communications, namely: Italy (20 February 2014), Iceland (7 March 2014), Ireland (7 March 2014) and Norway (10 March 2014). Submissions of three Parties (Malta, Monaco and Slovenia) are still pending. In response to the reminder sent by the secretariat regarding the submission due date, these Parties indicated that they are progressing in preparing their sixth national communications and that they expect their submissions in the first quarter of 2014.
