Information on the delay in submission of fifth national communications from Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol

Note by the secretariat

- 1. This note provides information on the delay in submission of fifth national communications from Parties included in Annex I to the Convention (Annex I Parties). It includes information available as of 18 February 2010 and covers only information on Annex I Parties to the Kyoto Protocol.
- 2. Through decision 10/CP.13, Annex I Parties were requested to submit their fifth national communications under the Convention by 1 January 2010 in accordance with Article 12, paragraphs 1 and 2 of the Convention. In accordance with decision 8/CMP.3, Annex I Parties that are also Parties to the Kyoto Protocol shall include, in the fifth national communications submitted in accordance with Article 12, paragraphs 1 and 2, of the Convention and decision 10/CP.13, the necessary supplementary information required under the guidelines for reporting supplementary information under Article 7, paragraph 2, of the Kyoto Protocol contained in the annex to decision 15/CMP.1.
- 3. The Guidelines for review under Article 8 of the Kyoto Protocol (as contained in the annex to decision 22/CMP.1) stipulate that "If a Party included in Annex I expects difficulties with the timeliness of its national communication submission, it should inform the secretariat before the due date of the submission. If the national communication is not submitted within six weeks after the due date, the delay shall be brought to the attention of the COP/MOP and the Compliance Committee and made public" (para. 139).
- 4. The secretariat, in its message to Parties to the Kyoto Protocol dated 2 November 2009, drew the attention of those Parties to the Kyoto Protocol that are included in Annex I to the Convention to the reports required under the Protocol during the first commitment period and their corresponding due dates. The secretariat also drew the attention of the Parties on the implications from the delays in the submission of the national communications under the Kyoto Protocol.¹
- 5. By 15 February 2010, the secretariat had received fifth national communications² from 33 Annex I Parties. As at this date, the secretariat had not received fifth national communications from seven Annex I Parties, namely Austria,³ Italy, Latvia, Monaco, Poland, Slovenia and Turkey. The secretariat received 17 notifications by Annex I Parties expecting difficulties with the timeliness of their national communication submission. The secretariat did not receive a fifth national communication within six weeks after the due

date or information on difficulties with the timeliness of the submission of their national communications from three Parties, namely, Italy, Monaco and Poland.

6. Information on the date of submission of the fifth national communications and expected difficulties with the timeliness of submission of the fifth national communications communicated to the secretariat as at 18 February 2010 is included in Table 1.
