## Annual status report of the greenhouse gas inventory of Slovakia

1. This status report was prepared by the expert review team in accordance with decision 22/CMP.1 as part of the initial check of the greenhouse gas inventory submitted. It reflects the content of the inventory of 2008 as submitted by the Party.

National inventory report	Description	The organization of the NIR, in general, follows the structure as outlined in the revised UNFCCC reporting guidelines (decision 18/CP.8). However, some of the recommended annexes such as “CO <sub>2</sub> reference approach and comparison with sectoral approach, and relevant information on the national energy balance” and “Assessment of completeness” are not provided. Slovakia stated, in its response to the draft status report that this information is included in chapter 1.4 and chapter 3.1.1 of the NIR.

Common reporting format	Missing source category larger than 7 per cent for Annex A sources	In the 2007 GHG inventory submission “Iron and steel – other fuels (1.A.2.a)” was identified as a source category contributing 7 per cent or more to total national GHG emissions. In the 2008 GHG inventory this source category is reported as not occurring (“NO”) for CO <sub>2</sub> , CH <sub>4</sub> and N <sub>2</sub> O. In its response to the draft status report, Slovakia stated: The explanation is given in the NIR 2008, chapter: 3.1.1 - Energy Industry (page 33). The reallocation of the category of other fuels in the Energy sector (sectoral approach) was provided according to the recommendations of the ERT during in-country review (19-24 March 2007). The category of other fuels in the Iron and steel industry (1.A.2.a) included other gaseous secondary fuels from production and technology, such as furnace gas, coke oven gas and so on. The reallocation of the fuels does not change the total of the source category and impacts only the sum of gaseous fuel sub source for the time series.
