





Annual status report of the annual inventory of Finland

Note by the secretariat

The annual status report of the annual inventory of Finland was published on 22 June 2009. For purposes of rule 10, paragraph 2, of the Rules of procedure of the Compliance Committee (annex to decision 4/CMP.2, as amended by decision 4/CMP.4), the report is considered received by the secretariat on the same date. Annual status report of the annual inventory of Finland

1. This status report was prepared by the secretariat as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2009 as originally submitted by the Party.
