





Annual status report of the annual inventory of Estonia

Note by the secretariat

The annual status report of the annual inventory of Estonia was published on 22 June 2009. Annual status report of the annual inventory of Estonia

1. This status report was prepared by the secretariat as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2009 as originally submitted by the Party.
