## **Annual status report of the annual inventory of Belgium**

### **Note by the secretariat**

The annual status report of the annual inventory of Belgium was published on 22 June 2010. ## Annual status report of the annual inventory of Belgium

However, the executive summary has not been provided, and some of the recommended annexes such as “CO <sub>2</sub> reference approach and comparison with sectoral approach” and “Assessment of completeness” are not provided. Belgium stated, in its response to the draft status report, that some information such as CO <sub>2</sub> reference approach and comparison with sectoral approach and Assessment of completeness are not included in recommended annexes but included in the report itself - chapters 1.8 and 3.2.1.
