## **Annual status report of the annual inventory of Ireland**

### **Note by the secretariat**

The annual status report of the annual inventory of Ireland was published on 22 June 2010. ## Annual status report of the annual inventory of Ireland

NIR	Description	The organization of the NIR, in general, follows the structure outlined in the updated UNFCCC reporting guidelines <sup>e</sup> on annual inventories following incorporation of the provisions of decision 14/CP.11, elaborated with annotated outline of the NIR. However, some of the recommended annexes such as key categories, “Detailed discussion of methodology and data for estimating CO <sub>2</sub> emissions from fossil fuel combustion”, “Assessment of completeness”, and “Table 6.1 and 6.2 of the IPCC good practice guidance” are not provided. Ireland stated, in its response to the draft status report, that these information are provide in the NIR: in Annex B (p.214-216), Annex C (p.218-277), Annex D, and Comparison of Reference and Sectoral Approach (p278-279); in Chapter 1 Section 1.9 (p. 24) and in Table 1.10 (p. 32); in Chapter 1 Section 1.5 (p. 19), in Table 1.6 (p. 26), in Table 1.7 p.27) and in Table 1.8 (p.28); and in Chapter 1 Section 1.7 (p. 23) and Table 1.9 Tier 1 Uncertainty Estimates for 2008 (p. 2931), respectively.
