## **Annual status report of the annual inventory of Luxembourg**

### **Note by the secretariat**

The annual status report of the annual inventory of Luxembourg was published on 22 June 2010. ## Annual status report of the annual inventory of Luxembourg

1. This status report was prepared by the secretariat as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2010 as originally submitted by the Party, and of the resubmission received by the secretariat by 27 May 2010.
