Annual status report of the annual inventory of the United Kingdom of Great Britain and Northern Ireland

- 1. This status report was prepared by the secretariat as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2010 as originally submitted by the Party, and of the resubmission received by the secretariat by 27 May 2010.
