Note by the secretariat

The annual status report of the annual inventory of Austria was published on 5 June 2013. Annual status report of the annual inventory of Austria

1. This status report was prepared by the expert review team as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2013 as originally submitted by the Party, and of the resubmission received by 27 May.
