Annual status report of the annual inventory of Bulgaria

Note by the secretariat

The annual status report of the annual inventory of Bulgaria was published on 5 June 2013. For purposes of rule 10, paragraph 2, of the Rules of procedure of the Compliance Committee (annex to decision 4/CMP.2, as amended by decision 4/CMP.4), the report is considered received by the secretariat on the same date. Annual status report of the annual inventory of Bulgaria

1. This status report was prepared by the expert review team as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2013 as originally submitted by the Party, and of the resubmission received by 27 May.
