Annual status report of the annual inventory of the Russian Federation

Note by the secretariat

The annual status report of the annual inventory of the Russian Federation was published on 18 June 2014. For purposes of rule 10, paragraph 2, of the Rules of procedure of the Compliance Committee (annex to decision 4/CMP.2, as amended by decisions 4/CMP.4 and 8/CMP.9), the report is considered received by the secretariat on the same date. This report, FCCC/ASR/2014/RUS, contained in the annex to this note, is being forwarded to the Compliance Committee in accordance with section VI, paragraph 3, of the annex to decision 27/CMP.1 and paragraph 49 of the annex to decision 22/CMP.1.



Annual status report of the annual inventory of the Russian Federation

1. This status report was prepared by the expert review team as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2014 as originally submitted by the Party, and of the resubmission received by 27 May 2014.
