Latest news

On 24 October 2012, the enforcement branch decided that there no longer continues to be a question of implementation with respect to Lithuania's eligibility, and that Lithuania is now fully eligible to participate in the mechanisms under Articles 6, 12 and 17 of the Kyoto Protocol.

The compliance procedure with respect to Lithuania

- 1) Lithuania submitted its 2010 annual inventory submission to the secretariat on 14 April 2010. On 7 September 2011, an international team of experts (expert review team) finalized its report of the individual review of the 2010 annual submission of Lithuania. The individual review report contains a question which triggered the compliance mechanism of the Protocol.
- 2) The question relates to the national system of Lithuania, as well as Lithuania's reporting commitments. A national system includes the institutional, legal and procedural arrangements for estimating emissions and sinks covered by the Protocol, and for reporting and archiving this information.
- 3) Lithuania was given an official notification of the question of implementation on 8 September 2011. The question was allocated to the enforcement branch on 15 September 2011 and the branch decided to proceed with its consideration of the question on 4 October 2011. The question of implementation with respect to Lithuania does not relate directly to whether it is in compliance with its 2012 emissions target.
- 4) A written submission was made by Lithuania on 8 November 2011 and, at the request of Lithuania, the enforcement branch held a hearing during its sixteenth meeting held in Bonn from 14 to 18 November 2011. The enforcement branch adopted a preliminary finding of non-compliance with respect to Lithuania on 17 November 2011.
- 5) Lithuania made a further written submission on 19 December 2011. After considering the further written submission by Lithuania, on 21 December 2011 the branch adopted a final decision to confirm its preliminary finding.
- 6) Lithuania was found to be in non-compliance with national system requirements for countries with 2012 targets (Annex B Parties). The national system is required for a country to account for its emissions and demonstrate compliance. This is not directly related to whether Lithuania is in compliance with its 2012 emissions target.
- 7) As a result of the final decision, the following <u>consequences</u> were applied by the branch with immediate effect to Lithuania:
 - a. Declared to be in non-compliance;
 - b. Required to submit a plan to address its non-compliance within three months;
 - c. Not eligible to participate in the market-based mechanisms (Article 17, emissions trading; Article 12, clean development mechanism; and Article 6, joint implementation). This means that Lithuania cannot sell and transfer credits (unless they are emission reduction units generated from joint implementation projects hosted by Lithuania and verified under a special track II joint implementation procedure), and cannot acquire any credits except those forwarded by a host developing country.
- 8) On 26 March 2012, Lithuania submitted a plan to address its non-compliance, which also included a first progress report on its implementation. The enforcement branch reviewed and assessed the plan submitted by Lithuania and concluded that the plan sets out and adequately addresses the relevant

- requirements and, if implemented in accordance with this decision, is expected to remedy the non-compliance.
- 9) On 14 June 2012, Lithuania submitted the second progress report on the implementation of the plan and a request to reinstate its eligibility to participate in the mechanisms under Articles 6, 12 and 17 of the Kyoto Protocol. This request was based on conclusions contained in an expert review team report of its review of the 2011 annual submission of Lithuania.
- 10) At its twentieth meeting, held in Bonn from 9 to 14 July 2012, the branch considered the request for reinstatement and concluded, after receipt of expert advice, that the question of implementation has not been resolved and decided not to reinstate Lithuania's eligibility to participate in the mechanisms under Articles 6, 12 and 17 of the Kyoto Protocol. The branch further decided to initiate the expedited procedure referred to in paragraph 1 of section X of the procedures and mechanisms relating to compliance under the Kyoto Protocol (annex to decision 27/CMP.1), unless Lithuania requests the branch before 31 July 2012 not to initiate this procedure. The branch also concluded that another incountry review is required.
- On 18 July 2012, the secretariat received a request from Lithuania for the branch not to initiate the procedure referred to in paragraph 1 of section X "before the report of the review of the National Greenhouse Gas Inventory, submitted in 2012, will be published."
- 12) On 31 July 2012, the branch decided not to initiate the procedure referred to in paragraph 1 of section X pending the receipt by the branch of the report of an in-country review of Lithuania's national system in conjunction with the review of its annual inventory report submitted in 2012. On 11 October 2012, the report on the expedited review for Lithuania conducted from 28 to 29 September 2012 was published. The report concluded that the question of implementation for Lithuania had been fully resolved.
- 13) At its twenty-first meeting held from 22 to 24 October 2012, the branch concluded, after receipt of expert advice, that there no longer continues to be a question of implementation. Lithuania became fully eligible to participate in the mechanisms on 24 October 2012 at 10:47:02, Greenwich Mean Time.

What the Compliance Committee does and the rules it follows

- 14) The <u>Compliance Committee is an independent body</u> set up to facilitate, promote and, where necessary, enforce compliance with the rules of the Kyoto Protocol. The Committee is composed of two branches: the enforcement branch, which is made up of legal experts from developed and developing countries; and the facilitative branch, which is made up of experts from developed and developing countries with competence related to climate change and in relevant fields.
- 15) The members and alternate members of the Compliance Committee take an oath, which included a commitment to be <u>impartial</u> and conscientious as well as an undertaking on <u>confidentiality</u>, which means that they <u>cannot comment on closed discussions of the branch</u>. The branch speaks through its written decisions.
- The rules relevant to recent and current cases include, for example, that a <u>national system</u> is required to produce a reliable accounting of greenhouse gas (GHG) activity so that a country can demonstrate compliance with its 2012 emissions target and that a country must have a national registry to account for its emissions credits.
- 17) Cases come to the Committee in the form of 'questions of implementation' from a Kyoto Party or an expert review team (of independent experts from different countries). So far, most of the questions of implementation have been allocated to the enforcement branch, in accordance with its mandate. The branch may and has sought expert advice, in particular it asked members of the expert review team to present their report and advice, and also asked other independent experts for their advice. The Party concerned may also make written submissions and present its views during a hearing.

- 18) In all cases of non-compliance, the enforcement branch of the Compliance Committee makes <u>a public</u> <u>declaration</u> of non-compliance and of the consequences applied.
- 19) Any country in non-compliance must submit a 'compliance action plan' within three months of a decision by the enforcement branch. The plan is subject to review and assessment by the enforcement branch (the timing of the review and assessment is case specific, and the branch is expected to complete it within four weeks).
- 20) Countries that are found not to meet the core eligibility criteria for the Kyoto mechanisms (emissions trading, the clean development mechanism and joint implementation) are <u>suspended</u> from trading in the official Kyoto carbon market set up by these mechanisms.
- 21) <u>Non-compliance with emissions targets</u> is not an issue that can come before the enforcement branch until after the end of the first commitment period in <u>2012</u>.
 - a. A country in non-compliance with its 2012 target has 100 days after the expert review of its final emissions inventory to make up any shortfall (i.e., to buy credits).
 - b. If such a country still misses its target, it must make up the difference, plus 30%, in the second commitment period after 2012. It is also suspended from selling emissions credits in the emissions trading mechanism and, within three months, it must submit a plan on the action it will take to meet its target for the second commitment period.
- 22) There are no financial penalties under the Kyoto Protocol, nor is there any consequence which involves loss of credits (although there is a loss of access to the carbon market).
- 23) Any country found in non-compliance can appeal to the Parties (CMP) against a decision of the enforcement branch, but only for issues relating to its 2012 target and only in the case of denial of due process.
