Concrete examples from EU submission:

Monitoring grass from space: to help establish early warning systems for future fodder crises in Ireland (*Spatial Analysis laboratory in Teagasc*).



Austrian Climate Research Programme AgroDroughtAustria:

The aim of this project is to **develop and test a crop specific operational drought monitoring and forecasting system for agriculture** in Austria. The objectives include the establishment and calibration of indicators and methods on crop specific drought and heat vulnerability and impacts based on field experiment data and crop model application. Further, a high spatial resolution model for crop drought and heat stress assessment will be applied (*Univers. For applied Sciences*)



Processes involved under the Convention and other international initiatives:

- UNFCCC Technology Mechanism and CTCN (Climate Technology Centre and Network)
- Nairobi Work Programme (Dissemination of knowledge, Regional Workshops)
 - UNISDR (UN Office for Disaster Risk Reduction)
- NAPs (National Adaptation Plans) developing and implementing adaptation strategies
- Global Framework for Climate Services (GFCS), an initiative under the WMO
- Joint workshop of IPCC, UNFCCC and GCOS in February 2015 on enhancing observations (pilot projects in developing countries have been proposed)
