What is meant by coordination of support?

- Many different vehicles for support for the implementation of REDD+ activities
 - Domestic
 - Bilateral
 - Non-Governmental
 - Private Sector
 - Multilateral
 - All: market and/or non-market
- How do we ensure this support contributes effectively to implementing coherent national REDD+ strategies?

Coordination underway

- Domestic: Efforts on donor coordination,
 REDD+ strategies ✓
- Bilateral: 5-Party Donor coordination,
 SilvaCarbon, FCMC, etc ✓
- Multilateral: Coordination among FCPF,
 FIP, UN-REDD ✓
- All: Voluntary REDD+ Database ✓

Barriers remain

- Weak systems/ capacity
- Little domestic coordination of partners
- Few published national strategies/ action plans
- Lack of visibility on gaps, uses of other finance
- Few registries to track units, transactions
- Lack of agreed methodological approaches

Barrier? Opportunity!

Multiple vehicles for finance

- Fulfill different priorities and needs
- Allow each country to choose the financing approach that best fits its national circumstances

New institution?


New body or institutional arrangement, similar to the Tech or Adaptation Committees?

- Reports and information analysis
- Information sharing, exchanges of information sharing, lessons learned

New institutional arrangement?

- Proposed functions are already filled
- Doesn't address identified barriers
- Takes a lot of time: creates delays, additional costs
- Our judgment: this would not contribute effectively to implementing coherent national REDD+ strategies

Better question?

How do we ensure support contributes more effectively to the implementation of REDD+?

Making support more effective

- Additional focus on building stronger systems, institutions, capacity
- National processes to facilitate coordination among partners
- Clear national visions: progress on national strategies/ action plans
- Visibility on gaps, uses of finance
- Use of appropriate tools, risk reduction
- Development of unit registries
- Agreed methodological guidance
