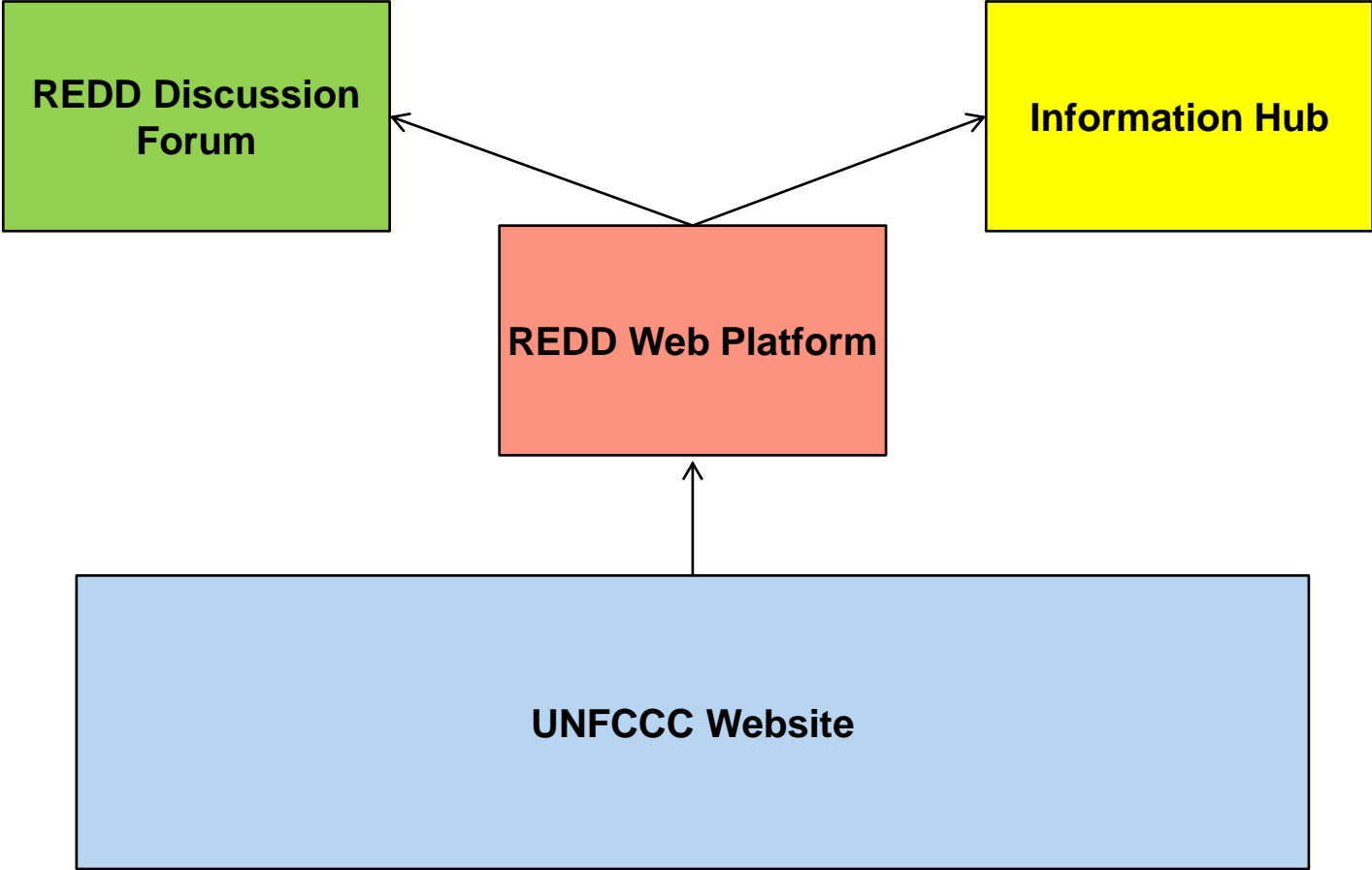


The COP

- **Paragraph 9:** *Decides* to establish an information hub on the web platform on the UNFCCC website as a means to publish information on the results of the activities referred to in decision 1/CP.16, paragraph 70, and corresponding results-based payments;
- **Paragraph 19:** *Requests* the secretariat to improve and further develop the web platform on the UNFCCC website to include the information referred to in paragraphs 11 and 12 above, and to make the information available in a simple, transparent and easily accessible manner;

Ongoing information sharing on the REDD Web Platform

- Parties, relevant organizations and stakeholders have been invited to share lessons learned and experiences gained on REDD-plus activities by submitting information to the secretariat for posting on the REDD Web Platform
- Provided information that has to be published on the REDD Web Platform:
 - a) Submissions with proposed reference levels
 - b) Final report on the technical assessment of REDD-plus reference levels
 - c) Technical report on the analysis of REDD-plus results
 - d) Summary of information on how all of the safeguards are being addressed and respected throughout the implementation of the activities
 - e) Results of addressing the drivers of deforestation and forest degradation

REDD Web Platform

Welcome to the REDD information sharing web platform.

The COP has invited Parties, relevant organizations and stakeholders to support ongoing efforts, capacity building, demonstration activities and mobilization of resources relating to reducing emissions from deforestation and forest degradation in developing countries and to share the outcomes of these efforts with the SBSTA by providing corresponding information to the secretariat. In [decision 2/CP.13](#) the COP also requested the secretariat to develop a web platform where this information will be made available.

The information shared on this web platform can be accessed through three entry points:

- [By submitting organization](#)
- [By topic](#)

Parties, relevant organizations and stakeholders are encouraged to submit information relating to reducing emissions from deforestation and forest degradation in developing countries (REDD) to this web platform. Information can be submitted in the form of plain text, PDF documents, and hyperlinks. Whenever sending PDF documents or hyperlinks it would be appreciated if you also added a short textual description (1-3 sentences).

In addition, the COP through its decisions agreed to make available information and reports relating to REDD-plus implementation on this platform. These include:

- Information on forest reference emission levels and/or forest reference levels, including submissions with proposed forest reference emission levels and/or forest reference levels ([decision 12/CP.17](#));
- The summary of information on how all of the safeguards referred to in [decision 1/CP.16](#), appendix I, are being addressed and respected throughout the implementation of the activities referred to in [decision 1/CP.16](#), paragraph 70 ([decision 12/CP.19](#));
- The final report of the technical assessment of forest reference emission levels and/or forest reference levels ([decision 13/CP.19](#));
- The technical report by the LULUCF experts included in the technical team of experts for the international consultation and analysis of results-based actions reported in a technical annex to the biennial update reports ([decision 14/CP.19](#));
- Results of the work by Parties, relevant organizations, and the private sector and other stakeholders to address drivers of deforestation and forest degradation ([decision 15/CP.19](#)).

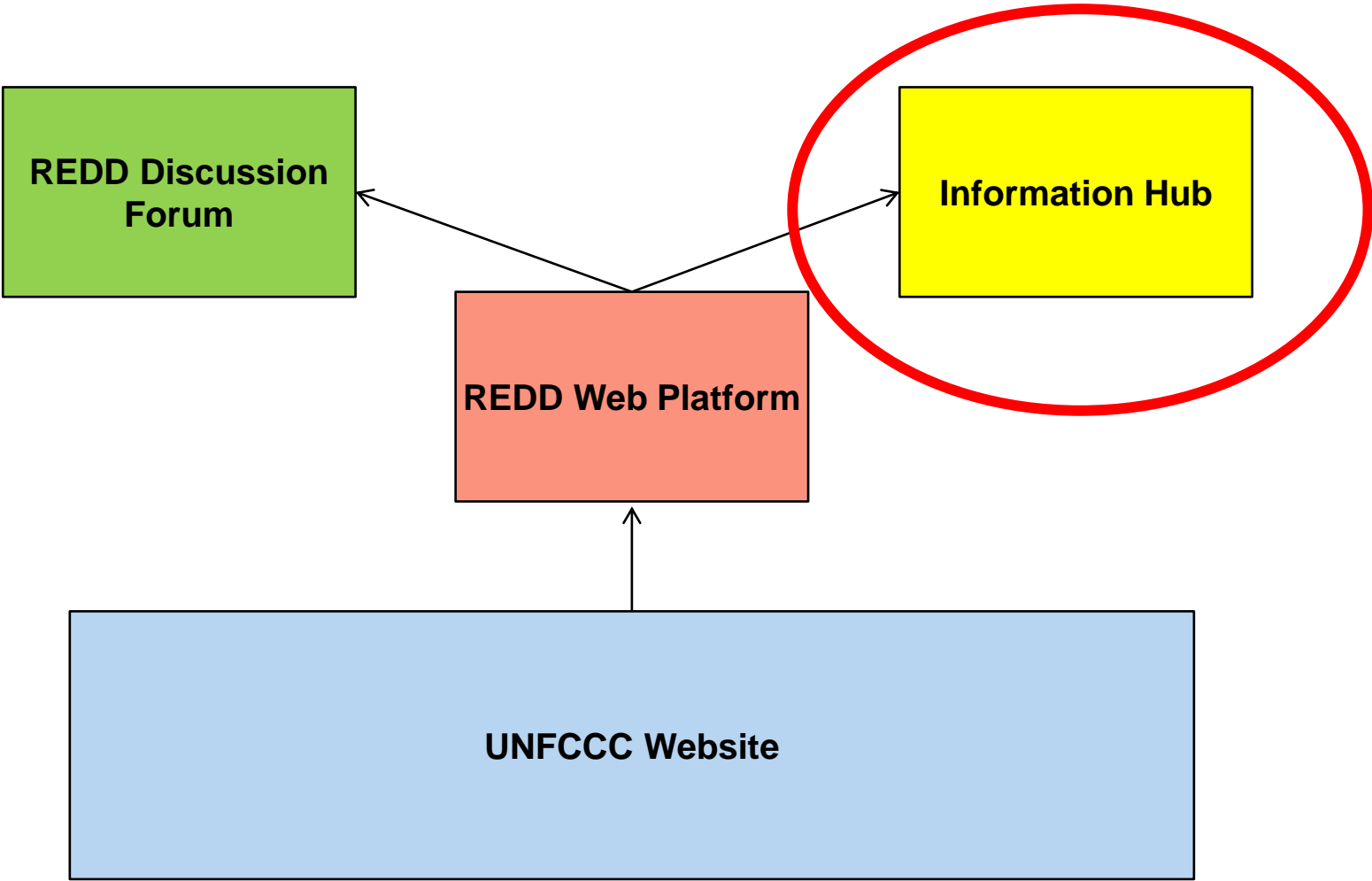
- User interface and database for sharing of information and searching information

UNFCCC REDD Web Platform



The information hub will contain:

- a) The results for each relevant period expressed in tonnes of carbon dioxide equivalent per year and a link to the technical report referred to in decision 14/CP.19, paragraph 14;
- b) The assessed forest reference emission level(s) and/or forest reference level(s) expressed in tonnes of carbon dioxide equivalent per year and a link to the final report of the technical assessment team referred to in decision 13/CP.19, paragraph 18;
- c) The summary of information on how all of the safeguards referred to in decision 1/CP.16, appendix I, are being addressed and respected, as referred to in decisions 12/CP.19 and 12/CP.17, chapter I;
- d) A link to the national strategy or action plan as referred to in decision 1/CP.16, paragraph 71(a), as appropriate;
- e) Information on the national forest monitoring system, as provided in the technical annex referred to in decision 14/CP.19;



Relationship between information hub and REDD web platform

1) For countries that have the necessary information for an entry on the information hub according to paragraphs 11-14 of decision 9/CP.19:

- Option a) A separate dedicated information hub country page could be created on the information hub
- Option b) The information could be listed in an overview information hub page for all countries
- Option c) Both of the above

Relationship between information hub and REDD web platform

2) Options for the design of the entry point of the information hub on the REDD Web Platform:

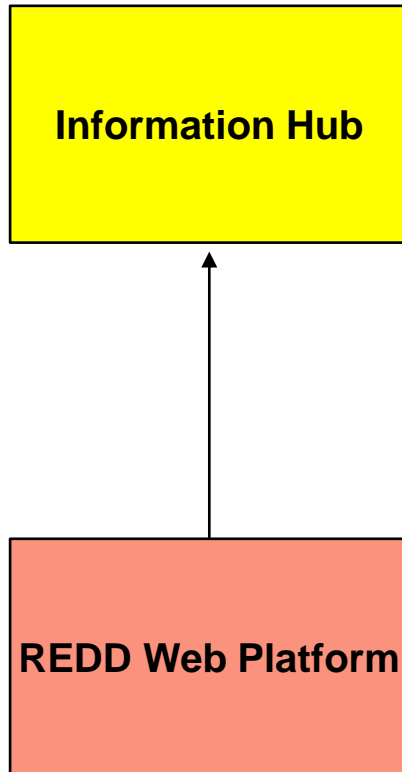
- Option a) Centrally on the start page of the REDD Web Platform, e.g. as a hyperlink and/or map
- Option b) On each dedicated country page on the REDD Web Platform once all of the relevant information is available for the country
- Option c) Both of the above



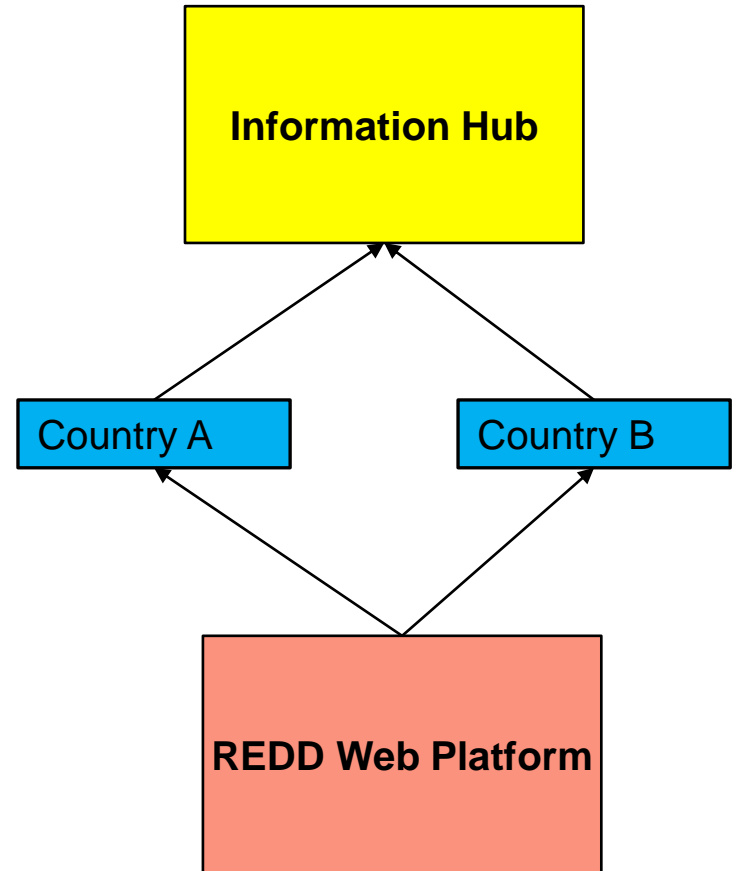
Relationship between information hub and REDD web platform

Option b): on country pages

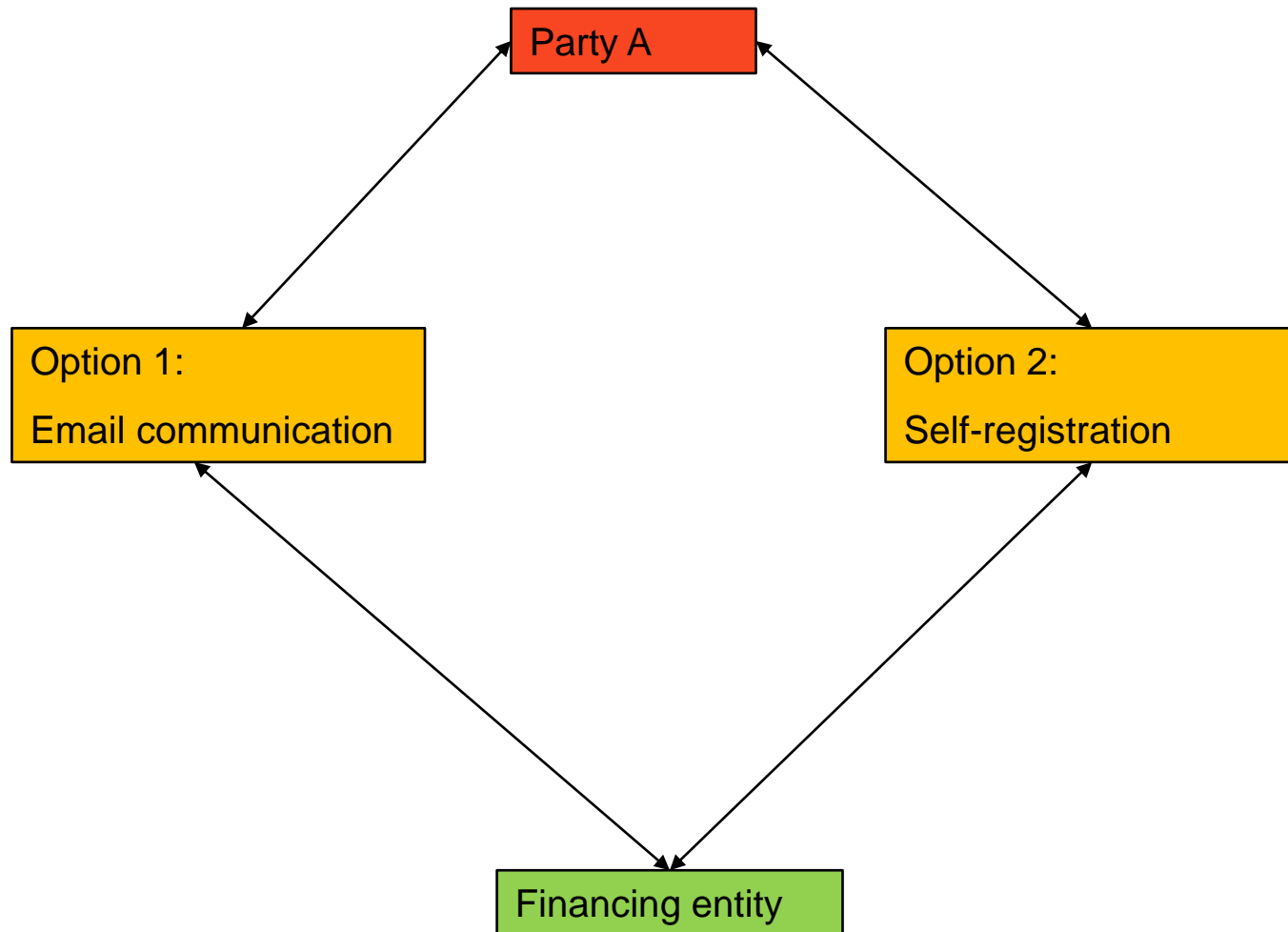


Consultation process

- For entering payments received for results by developing country Parties a communication process has to be established according to paragraph 13 of decision 9/CP.19.
- This process should also extend to allow for consultation with the developing country Party concerned if such payments are communicated by any other entities.
- Two basic options can be identified for such a consultation process:
 - 1) Email communication
 - 2) Self-registration

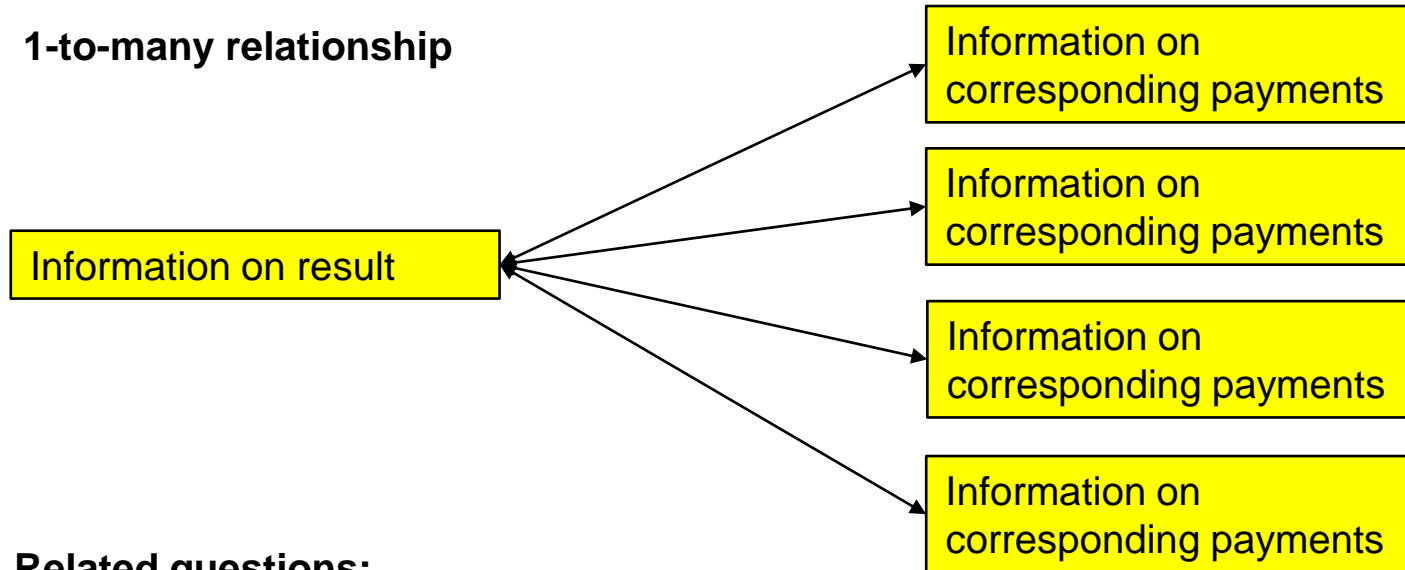

- Some additional information would probably be needed for each result in order to differentiate between entries, e.g. the name of the submitting country and the submission year or date.

- There are some options on technical setup and display of information which will be discussed further at this meeting
- Using similar technology and design for the information hub and the upgrade of the REDD Web Platform will lead to efficiency gains (e.g. also user registration)
