THE BACKGROUND

- The World Conference on the “Rights of People and Mother Earth” held in Bolivia (Tiquipaya, April 2010): **NO REDD+**.
- Bolivia addresses holistic, comprehensive and integrated approaches to achieve sustainable forestry development; therefore: joint mitigation and adaptation approaches in the context of climate change.
- REDD+ must be developed in tune with the general discussion and decisions about sustainable development and forests at United Nations.

PRINCIPAL DECISIONS AT UNITED NATIONS ADDRESSING NON-MARKET BASED APPROACHES

Conference on Sustainable Development of Rio+20 (Rio, June 2012)

56. We affirm that there are different approaches, visions, models and tools available to each country, in accordance with its national circumstances and priorities, to achieve sustainable development in its three dimensions which is our overarching goal.

Paragraphs of the UNFCCC decision 2/CP.17 (Durban, Dec. 2011)

67. Notes that non market based approaches, such as **joint mitigation and adaptation approaches for the integral and sustainable management of forests** as a non-market alternative... could be developed;

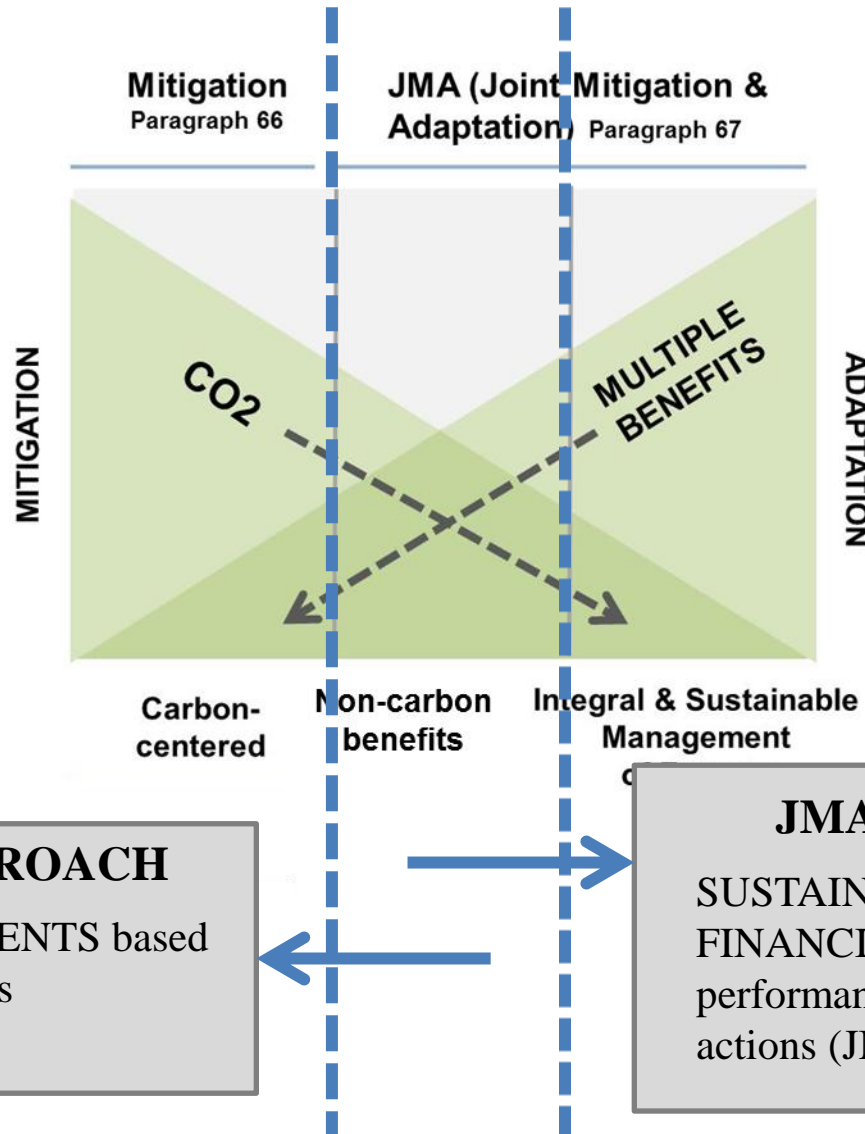
SBST 38 (June 2013)

14. The SBSTA noted that non-market-based approaches, such as joint mitigation and adaptation approaches for the integral and sustainable management of forests, as referred to in decision 2/CP.17, paragraph 67, are important to support the implementation of the activities referred to in decision 1/CP.16, paragraph 70.

Decisions adopted by the Governing Council/Global Ministerial Environment Forum at its first universal session (Decision 27/8)

Acknowledges that there are different approaches, visions, models and tools developed by Member States of the United Nations in order to achieve sustainable development, and in this regard takes note of the approach of **Living-Well in balance and harmony with Mother Earth (...)**

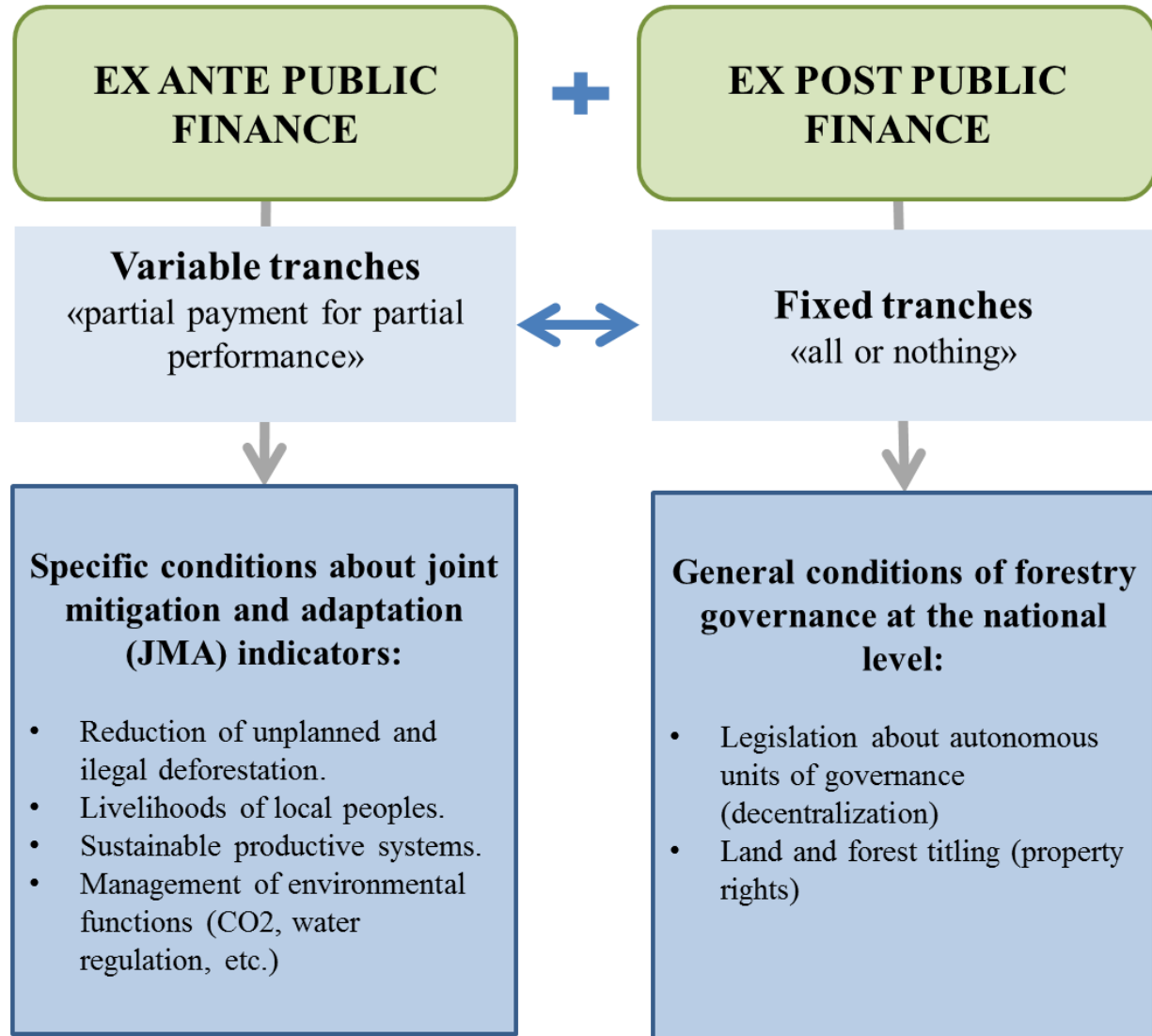

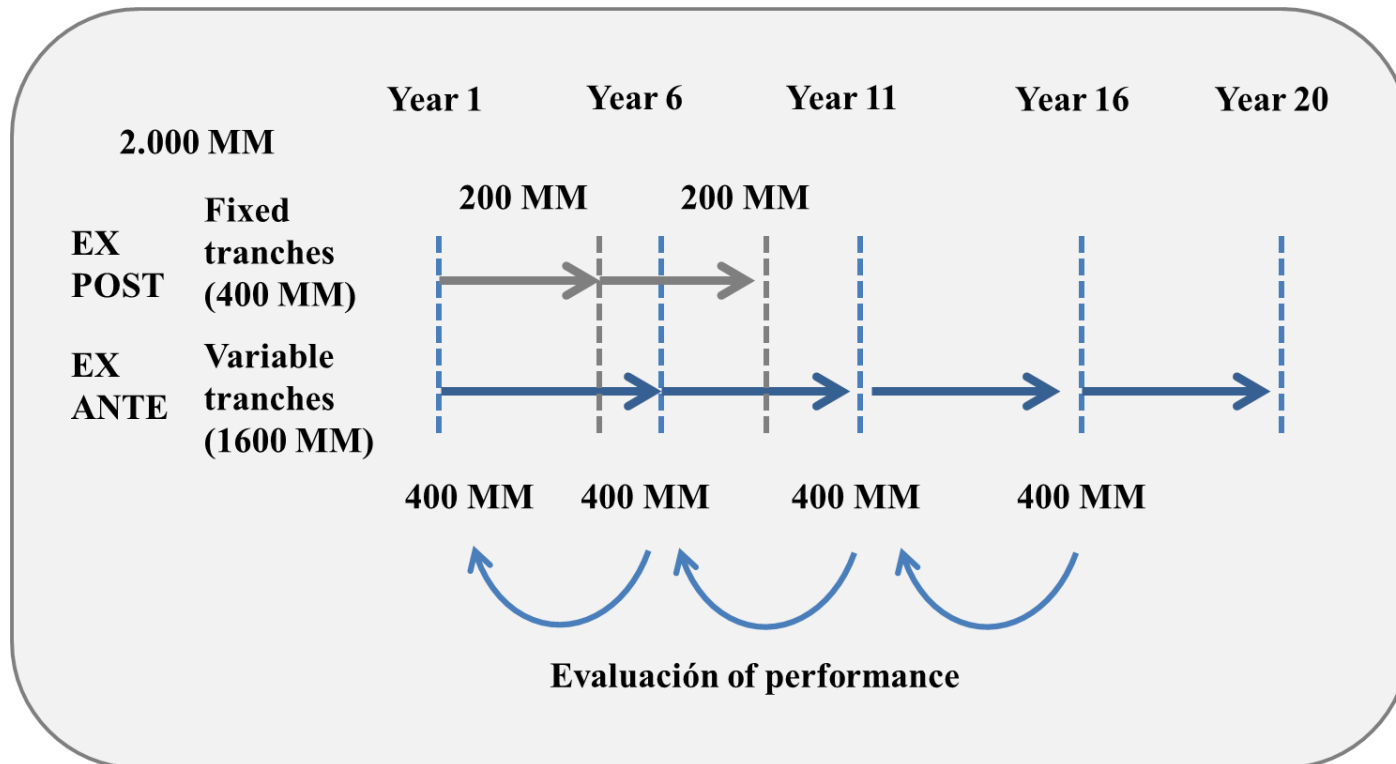

EXAMPLE OF A JMA PROGRAMME FOR A PERIOD OF 20 YEARS IN A DEVELOPING COUNTRY

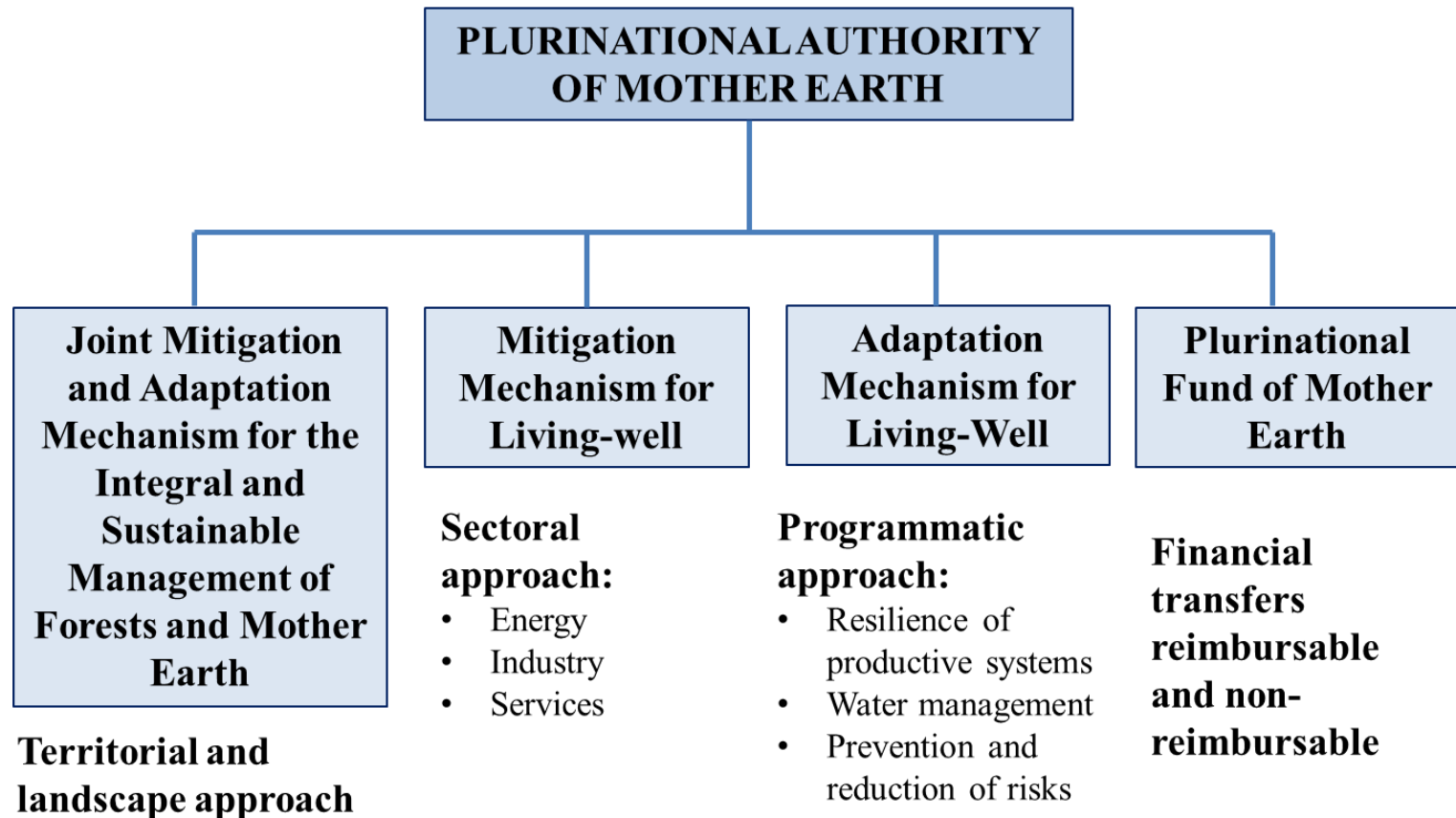




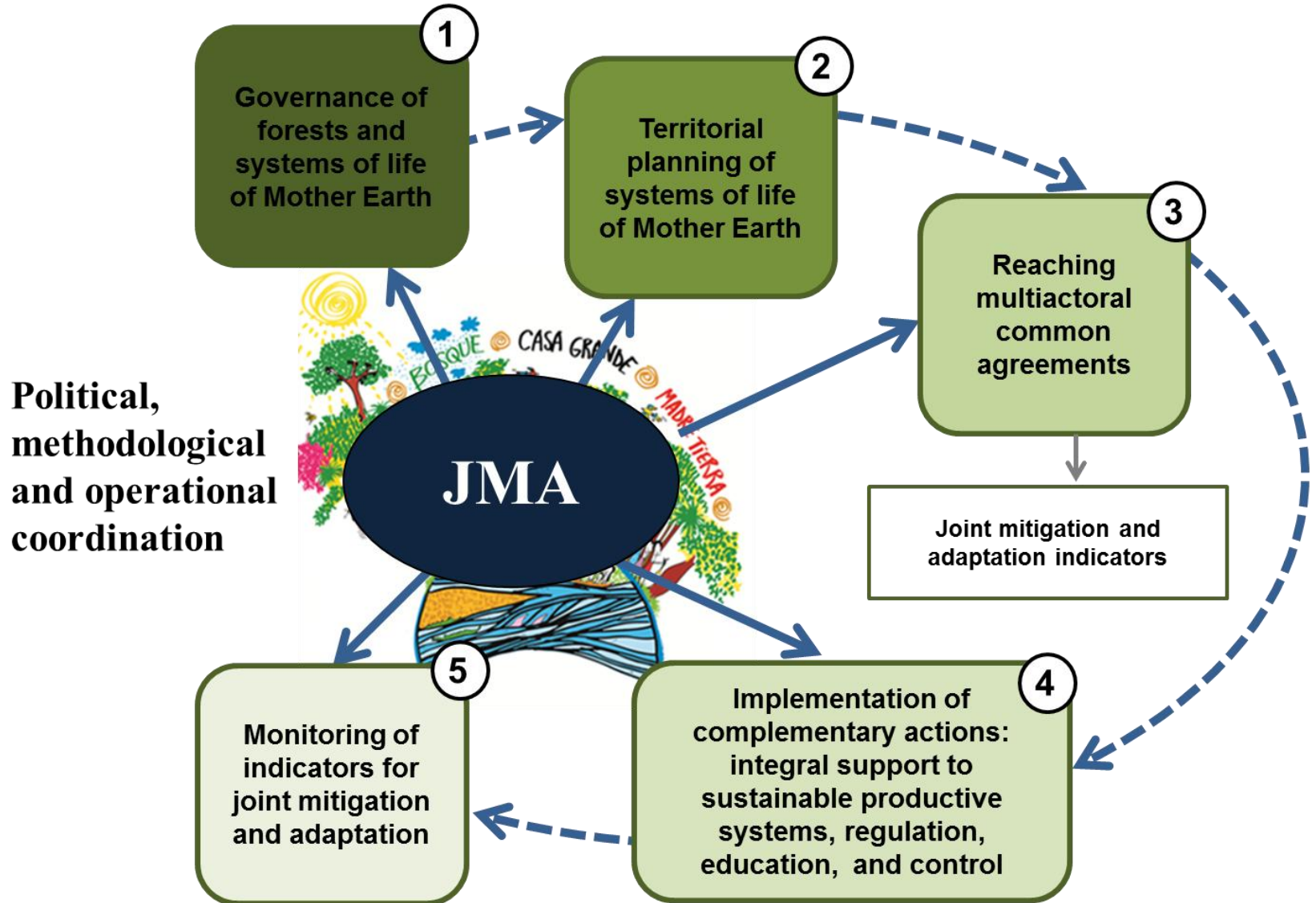
The Joint Mitigation and Adaptation approach in Bolivia
