LATIN AMERICA – CARIBBEAN REGIONAL CONSULTATION AND CAPACITY-BUILDING WORKSHOP ON REDUCING EMISSIONS FROM DEFORESTATION AND FOREST DEGRADATION IN DEVELOPING COUNTRIES (REDD-PLUS<sup>1</sup>), INCLUDING ON RELEVANT BIODIVERSITY SAFEGUARDS

#### ANNOTATIONS TO THE PROVISIONAL AGENDA

#### I. INTRODUCTION

- 1. The Latin America Caribbean regional consultation and capacity-building workshop on REDD-plus, including on relevant biodiversity safeguards, to be held in Quito, Ecuador, from 5 to 8 July 2011, is being co-organized by the Secretariat of the Convention on Biological Diversity (CBD) and the Ministry of Environment of the Republic of Ecuador, with the generous financial support of the Government of Japan in its capacity as current Presidency of the Conference of the Parties to the Convention, the UN-REDD Programme<sup>2</sup>, and the Government of Ecuador as host country. The organizers gratefully acknowledge that several of the members of the Collaborative Partnership on Forests (CPF) and other relevant organizations will contribute to the workshop by providing information about their work on REDD-plus.
- 2. Pursuant to paragraph 3 (b) of decision IX/5, the workshop aims to support Parties to the Convention on Biological Diversity in the Latin America Caribbean region which are in the process of planning or implementing activities to reduce emissions from deforestation and forest degradation. The workshop is the second in a series of three regional workshops, following a workshop for Asia-Pacific, held in Singapore, 15-18 March 2011, and preceding a workshop for Africa, to be held in South Africa in 2011 (dates to be decided).
- 3. The objectives of the workshop are:
- (a) To develop advice, including on the application of relevant safeguards for biodiversity, so that REDD-plus actions "are consistent with the objectives of the Convention on Biological Diversity and avoid negative impacts on and enhance benefits for biodiversity" (see decision X/33, para. 9 (h));

- (b) To identify possible indicators to assess the contribution of REDD-plus "to achieving the objectives of the Convention on Biological Diversity, and assess potential mechanisms to monitor impacts on biodiversity from REDD-plus and other ecosystem-based approaches for climate change mitigation measures" (see decision X/33, para. 9 (k));
- (c) To contribute to capacity-building on REDD-plus in the Latin America Caribbean region, including with a view to "enhancing the coordination of capacity-building efforts on issues related to biodiversity and ecosystem-based carbon sequestration and the conservation of forest carbon stocks" (see decision X/33, para. 9 (f));
- (d) To further enhance synergies between the implementation of the Convention on Biological Diversity and the United Nations Framework Convention on Climate Change (UNFCCC) through the design and implementation of the REDD-plus mechanism.
- 4. Acknowledging that socio-economic, ecological and other conditions vary amongst the countries that are involved in, or are in the process of engaging in, REDD-plus pilot and demonstration activities, the workshop will make provisions for working groups to discuss views, and share experiences and expectations, with regards to relevant REDD-plus safeguards and the monitoring and assessment of REDD-plus co-benefits.
- 5. The Secretariat has prepared a list of relevant documents that will be made available to the workshop participants with a view to facilitating the workshop discussions (see annex I). These documents include, *inter alia*, a paper on REDD-plus and biodiversity (CBD Technical Series No. 59) and the findings of the Ad Hoc Technical Expert Group on Biodiversity and Climate Change (CBD Technical Series No. 41).
- 6. Results of the workshop will be brought to the attention of the eleventh meeting of the Conference of the Parties to the Convention on Biological Diversity, as well as to the relevant bodies of the United Nations Framework Convention on Climate Change (UNFCCC).
- 7. Registration of participants will commence at 8 a.m. on Tuesday, 5 July 2011. Details of the meeting venue will be provided through subsequent notifications.
- 8. The workshop will include a one day excursion to a Socio Bosque Community<sup>3</sup> on Friday, 8 July 2011. Details of the excursion will be provided through subsequent communications to registered participants.
- 9. The workshop will be held in English and Spanish.

#### II. BACKGROUND

# REDD-plus under the UNFCCC and the Convention on Biological Diversity

- 10. At its ninth meeting, held in Bonn in May 2008, the Conference of the Parties to the Convention on Biological Diversity welcomed the consideration of the issue of reducing emissions from deforestation and forest degradation in the framework of the United Nations Framework Convention on Climate Change (see decision IX/16).
- 11. At its tenth meeting, held in Nagoya in October 2010, the Conference of the Parties invited Parties, other Governments, and relevant organizations and processes to enhance the benefits for, and avoid negative impacts on biodiversity from reducing emissions from deforestation and forest degradation

<sup>3</sup> The Socio Bosque Programme is an incentive policy for conservation of forests, Andean highlands and other native ecosystems of Ecuador. The program is aimed at delivering economic incentives to private landowners and communities that voluntarily wish to protect their forests, Andeans highlands and other native vegetation. The program aims at preserving 4 million acres of forest, Andeans highlands or other native vegetation to benefit 1 million people and significantly reducing GHG emissions from deforestation and forest degradation. The program has been implemented from September 2008. In December 2010 agreements for more than 600,000 acres have been signed, benefiting over 50,000 people.

and the role of conservation, sustainable management of forests and enhancement of forest carbon stocks in developing countries, and other sustainable land management and biodiversity conservation and sustainable use activities, taking into account the need to ensure the full and effective participation of indigenous and local communities in relevant policy-making and implementation processes, where appropriate; and to consider land ownership and land tenure, in accordance with national legislation (see decision X/33, para. 8 (q)).

- 12. In the same decision, the Conference of the Parties requested the Executive Secretary to provide advice, for approval by the Conference of the Parties at its eleventh meeting, including on the application of relevant safeguards for biodiversity, without pre-empting any future decisions taken under the United Nations Framework Convention on Climate Change, based on effective consultation with Parties and their views, and with the participation of indigenous and local communities, so that actions are consistent with the objectives of the Convention on Biological Diversity and avoid negative impacts on and enhance benefits for biodiversity (see decision X/33, para. 9 (g)).
- 13. The same decision also requested the Executive Secretary, with effective consultation with Parties and based on their views and in collaboration with the Collaborative Partnership on Forests, to identify possible indicators to assess the contribution of reducing emissions from deforestation and forest degradation and the role of conservation, sustainable management of forests and enhancement of forest carbon stocks in developing countries to achieving the objectives of the Convention on Biological Diversity, and assess potential mechanisms to monitor impacts on biodiversity from these and other ecosystem-based approaches for climate change mitigation measures, without pre-empting any future decisions taken under the United Nations Framework Convention on Climate Change, and to report on progress to the Subsidiary Body on Scientific, Technical and Technological Advice at a meeting prior to the eleventh meeting of the Conference of the Parties (see decision X/33, para. 9 (h)).
- 14. The same decision also requested the Executive Secretary to convene, subject to the availability of financial resources, in collaboration with the Secretariat of the United Nations Framework Convention on Climate Change an expert workshop, with the full and effective participation of experts from developing countries on reducing emissions from deforestation and forest degradation and the role of conservation, sustainable management of forests and enhancement of forest carbon stocks in developing countries, with a view to enhancing the coordination of capacity-building efforts on issues related to biodiversity and ecosystem-based carbon sequestration and the conservation of forest carbon stocks (see decision X/33, para. 9 (f)).
- 15. In notification 2011-018 (ref. no. SCBD/STTM/JM/TC/JSt/74726) issued on 24 January 2011, the Executive Secretary requested Parties and relevant organizations to submit their views in relation to the requests listed in paragraphs 9 (g) and (h) of decision X/33, by 30 April 2011. The views received by the Secretariat of the Convention on Biological Diversity will be compiled and made available in time for subsequent regional workshops on this topic; however, they will not be available in time for this workshop.
- 16. The Conference of the Parties to the UNFCCC, at its fifteenth session, adopted decision 4/CP.15 on the "Methodological guidance for activities relating to reducing emissions from deforestation and forest degradation and the role of conservation, sustainable management of forests and enhancement of forest carbon stocks in developing countries", in which it recognized the "importance of promoting sustainable management of forests and co-benefits, including biodiversity, that may complement the aims and objectives of national forest programmes and relevant international conventions and agreements."
- 17. At its sixteenth session, the Conference of the Parties to the UNFCCC adopted decision 1/CP.16, encouraging developing country Parties to contribute to greenhouse gas mitigation actions in the forest sector by undertaking REDD-plus activities. The implementation will take place in three different phases, starting with the development of national strategies or action plans, policies and measures, and capacity-building, followed by their implementation, and finally, evolving into fully-measured, reported and verified results-based actions.

- 18. In decision 1/CP.16, the Conference of the Parties to the UNFCCC affirmed that the implementation of REDD-plus activities should include the promotion and support of a number of safeguards, including:
- (a) That actions complement or are consistent with the objectives of national forest programmes and relevant international agreements;
- (b) Respect for the knowledge and rights of indigenous peoples and members of local communities, by taking into account relevant international obligations, national circumstances and laws, and noting that the United Nations General Assembly has adopted the United Nations Declaration on the Rights of Indigenous Peoples (Resolution 61/295 of 13 September 2007);
- (c) The full and effective participation of relevant stakeholders, in particular, indigenous peoples and local communities;
- (d) That actions are consistent with the conservation of natural forests and biological diversity, ensuring that they are not used for the conversion of natural forests, but are instead used to incentivize the protection and conservation of natural forests and their ecosystem services, and to enhance other social and environmental benefits;
  - (e) Actions to address the risk of reversals;
  - (f) Actions to reduce the displacement of emissions.
- 19. The Conference of the Parties to the UNFCCC requested that developing country Parties aiming to undertake REDD-plus activities develop:
  - (a) A national REDD-plus strategy or action plan;
  - (b) A national forest reference emission level and/or forest reference level;
  - (c) A robust and transparent national forest monitoring system;
- (d) A system for providing information on how the safeguards are being addressed and respected throughout the implementation of REDD-plus activities.
- 20. Furthermore, the Conference of the Parties to the UNFCCC invited relevant international organizations and stakeholders to contribute to REDD-plus activities.
- 21. The Secretariat of the UNFCCC will be invited to provide an update on the status of negotiations to workshop participants.

# Selection of workshop participants

22. In notification 2011-078 (ref. no. SCBD/STTM/JF/TC/JSt/75541), issued on 8 April 2011, the Executive Secretary of the Convention on Biological Diversity invited Parties and relevant organizations to nominate experts for the workshop. National focal points were encouraged to submit two nominations per country, if these experts were representing government responsibility for biodiversity issues in the context of the Convention on Biological Diversity, and forest-related issues in the context of UNFCCC. The Executive Secretary further invited donor countries, the co-chairs of the REDD-plus Partnership, the Coalition of Rainforest Nations, and non-governmental organizations with whom the Secretariat of the Convention on Biological Diversity had a memorandum of understanding at the date of notification, to participate in the workshop. Due to limited funding, the Secretariat will not be in a position to fund the participation of all nominated experts from developing countries. Selection of sponsored developing country participants will be made on basis of geographic and gender balance, relevant expertise, and language skills. Priority will be given to designated experts involved in national-level implementation of the Convention on Biological Diversity, and if additional funding is available, country-nominated experts such as Focal Points of the UNFCCC will be supported. The workshop is open to self-funded participants from Parties, other Governments, and from relevant organizations.

- 23. Indigenous organizations were invited to nominate representatives to participate in the workshop.
- 24. The UN-REDD Programme provided financial support for additional participants.
- 25. All members of the Collaborative Partnership Forests (CPF) have been invited, including the secretariats of the United Nations Framework Convention on Climate Change and the United Nations Forum on Forests.
- 26. The outcome of the workshop will be made available through the clearing-house mechanism of the Convention on Biological Diversity, and in the appropriate format to the eleventh meeting of the Conference of the Parties, to be held in India from 8 to 19 October 2012.
- 27. The workshop results will also be made available to the UNFCCC through other appropriate means, for example the Joint Liaison Group (JLG) and the UNFCCC REDD Web Platform<sup>4</sup>, and through submissions and statements of the Executive Secretary of the Convention on Biological Diversity to the relevant statutory meetings of the UNFCCC.
- 28. With financial support from the Global Environment Facility (GEF), eligible countries will conduct a revision of their national biodiversity strategies and action plans (NBSAPs) in the course of 2011. Workshop results will be made available to national focal points of the Convention on Biological Diversity and relevant organizations, *inter alia* in order to inform the revision of NBSAPs and their harmonization with respective plans and programmes under the UNFCCC. Workshop results will be made available for NBSAP workshops in the region.

#### ITEM 1. OPENING OF THE MEETING

29. The workshop will be opened at 9 a.m. on Tuesday, 5 July 2011. Welcoming remarks will be made by a representative of the Executive Secretary of the Convention on Biological Diversity, a representative of the Ministry of Environment of the Republic of Ecuador, and a representative from the UN-REDD Programme.

#### ITEM 2. ORGANIZATIONAL MATTERS

# 2.1. Election of officers

30. After a self-introduction of participants, the group will be invited to elect two Co-Chairs based on proposals from the floor.

# 2.2. Adoption of the agenda

31. The provisional agenda prepared by the Executive Secretary will be put before the group for consideration and adoption.

# 2.3. Organization of work

32. Under this item, the group will consider the proposed organization of work for the workshop as contained in annex II below.

# ITEM 3. REDD-PLUS UPDATE

33. Under this item, the Secretariat of the Convention on Biological Diversity will introduce the workshop documents, and will provide an overview of activities pursuant to decision X/33. The UNFCCC Secretariat will be invited to provide an update on relevant negotiations under the UNFCCC, and relevant activities of the UNFCCC Secretariat. The UN-REDD Programme and other international organizations and initiatives working on REDD-plus pilot and demonstration activities will be invited to provide an update on their activities with regard to biodiversity benefits of REDD-plus. A representative from the REDD-plus Partnership will be invited to give a presentation on the work programme of the

Partnership, including potential efforts related to safeguards on biodiversity conservation. The Global Environment Facility will be invited to provide information about financing options in the fifth replenishment period.

- 34. Participants will be invited to present an overview of national experience and views on REDD-plus safeguards for, and assessment and monitoring of impacts of REDD-plus on, biodiversity and indigenous and local communities. This is limited to one presentation per country. A list of suggested key questions as a basis for country presentations will be provided before the workshop.
- 35. Indigenous and local community representatives, and relevant organizations, will be invited to present experience on opportunities and challenges (including risks) of REDD-plus for biodiversity and indigenous and local communities.
- 36. In all presentations, presenters are encouraged to also reflect on future research needs and policy development needs for REDD-plus safeguards and REDD-plus impacts on biodiversity.

# ITEM 4. REDD-PLUS SAFEGUARDS AND ASSESSMENT/MONITORING OF IMPACTS

- 37. Under this item, the workshop participants will be organized in working groups to ensure that the workshop objectives can be achieved. The objective of dividing participants into working groups is to maximize the opportunity for participants to contribute their expertise. The three working groups should consist of a similar number of experts, taking into account regional balance, gender balance, representation of civil society organizations, and representation of indigenous and local communities.
- 38. Each working group will address three main issues: (i) developing advice on the application of relevant REDD-plus safeguards for biodiversity and indigenous and local communities; (ii) identifying possible indicators to assess the contribution of REDD-plus to achieving the objectives of the Convention on Biological Diversity; and (iii) possibilities for enhancing synergies at national level between the CBD and UNFCCC with regard to REDD-plus. Under each task, the working groups will be expected to provide detailed recommendations.
- 39. It is suggested that the working groups be facilitated by experts from partner organizations of the Convention on Biological Diversity, and that their outcomes be documented by a rapporteur chosen from the participants of each group.
- 40. Working groups will report back to plenary on their findings, and the Secretariat will compile results into a workshop report that will be presented to plenary for adoption on the final workshop day.

# ITEM 5. OTHER MATTERS

41. Under this item, participants may wish to raise other matters related to the subject-matter of the meeting, and to agree on any follow-up actions.

# ITEM 6. ADOPTION OF THE REPORT AND CLOSURE OF THE MEETING

- 42. The Co-Chairs will provide an overview of their conclusions, and their observations as to whether meeting objective has been achieved.
- 43. Participants will be encouraged to provide feedback and evaluate the meeting.
- 44. Participants will be invited to consider and adopt the report of the meeting, on the basis of the draft report of the meeting to be prepared and presented by the Co-Chairs.
- 45. The meeting is expected to be closed at 4:30 p.m. Thursday, 7 July 2011, in order to depart to an optional field visit, offered by the host country.
