

## **Informal meeting on mechanisms – NGO participation**

During the informal meeting on mechanisms (Lyon, 4-9 September 2000), in the evening session on 4 September (21:00-23:30), Mr. Chow Kok Kee, Chair of the meeting, would like to give the NGO constituencies the opportunity to provide additional input on the "**Consolidated text on principles, modalities, rules and guidelines**", contained in document FCCC/SB/2000/4.
