Background

Decision 1/CP.16 (2010):

- ❖ Build on **existing reporting and review guidelines**, processes and experiences, establishes a work programme:
 - ❖ The **revision of guidelines for the review of NC**, including the BR, **annual greenhouse gas inventories and national inventory systems**;

2/CP.17 (2011)

- ❖ Launches **work programme** on the **revision of the review guidelines** under the SBSTA, with a view to concluding them no later than COP 19;
- ❖ Secretariat to enhance **coordination** between different review processes to **ensure effective and efficient processes and procedures**.



Key highlights from work programme

SBSTA 36 (2012): Initial consideration of the work programme

- ❖ Parties to take into account **experience in reporting and review of information under the Convention** and need to have a **cost-effective, efficient and practical review process** that does **not impose excessive burden on Parties/secretariat**

SBSTA 37 (2012): Agreed on work programme

- ❖ NCs and BRs review guidelines will be **completed by COP 19**;
- ❖ GHG inventories review guidelines **can be completed by COP 20**;
- ❖ Lead reviewers to discuss in 2013 **options to improve the cost-effectiveness, efficiency and practicality** of the review process as input for SBSTA 38;
- ❖ **Technical workshops in 2013 and 2014 to advance the work**, and to prepare workshop reports as inputs to discussions at SBSTA;
- ❖ Work programme **could be adjusted and could be additional workshops** before COP 20.



Key highlights from work programme

SBSTA 38 (2013):

- ❖ **Focused mostly on NCs and BRs:** invited Parties submission of views on contents of review guidelines and addressed focus of 1st workshop to be held in Oct. 2013.
- ❖ **Noted that appropriate streamlining** could improve efficiency and cost-effectiveness of review process without compromising quality;
- ❖ The **same information submitted in NCs, BRs and GHG inventories would be reviewed only once;**
- ❖ Highlighted **importance of training** for the review of BRs and NCs, requested the secretariat to begin development of training materials for these reviews.



Key highlights from work programme: Warsaw

Decision 23/CP.19: Draft review guidelines for BRs, NCs

- ❖ Covered general aspects of all reviews; a placeholder for GHG inventories reviews

SBSTA 39 (2013)

- ❖ Welcomed **training materials** developed by secretariat on review of BRs and NCs and asked it to **develop a formal training programme for consideration at SBSTA 40**.
- ❖ Invited **Parties to submit detailed views** on the structure, outline, key elements, including the purpose and scope of the review, timing and reporting, and content of the Annex I GHG inventory review guidelines.
- ❖ Secretariat to make available a synthesis report and a draft of the revised review GHG inventory review guidelines as inputs to the 2nd technical workshop.
- ❖ Reiterated need to have a cost-effective, efficient and practical review process that does not impose an excessive burden on Parties, experts or the secretariat.
- ❖ Agreed work programme should be adjusted **and an additional technical workshop** held in the second half of 2014.

- ❖ **1/CP.16, para. 46** *Decides* on a work programme for the development of modalities and guidelines, building on existing reporting and review guidelines, processes and experiences
- ❖ **2/CP.17, para. 28:** *Decides* to establish a work programme under SBSTA
- ❖ **23/CP.19:** Draft revised guidelines with placeholder for inventory review guidelines
