Article 8 (CAPACITY-BUILDING)

1. ~~1.~~ Capacity-building under this Agreement should facilitate the enhancement of ability of Parties, particularly and capacity in all areas on climate change for developing countries, country Parties, in accordance with principles and provisions of the Convention to identify, design and implement adaptation and mitigation actions; facilitate technology development and the absorption of technology ~~and finance~~, facilitate access to finance, facilitate relevant aspects of education, training and public awareness; and facilitate the transparent, timely and accurate communication of information.

2. Capacity-building should be based on and respond to national needs and foster country ownership of developing country Parties, including at the national, sub-national and local levels. Capacity-building should be guided by lessons learned on capacity-building under the Convention and should be an effective, iterative process that is participatory, country-driven and cross-cutting. ~~Capacity-building should respond to national needs and foster country ownership, including at the national, subnational and local levels.~~

3. Developed country Parties [shall|should|other] scale up regularly prepare, communicate and implement plans, policies, actions and measures on capacity-building support to developing country Parties, in order to progressively scale up such support and cooperation to enhance the capacity of developing country Parties in need of support to implement this Agreement, including through regional, bilateral and multilateral approaches.

4. The provision of capacity-building by institutional arrangements established under the Convention shall serve this Agreement and shall be enhanced and their work intensified, as appropriate, within their respective mandates.

An international capacity-building mechanism shall be hereby established to serve this Agreement with enhance the intention capacity of enhancing the planning and implementation of mitigation and adaptation actions, including by improving coordination developing country parties to implement this Agreement.
