Dear Mr. de Boer.

The Government of the Republic of Mozambique is pleased to inform you, through this letter, of its desire to be associated with the Copenhagen Accord of 18th December 2009.

In taking this step, the Government of the Republic of Mozambique is of the view that the Copenhagen Accord constitutes a good basis for global engagement which will culminate in the adoption of a comprehensive, ambitious, and legally binding outcome during the forthcoming Conference of the Parties (COP16), to be held in Mexica, in November 2010.

The Government of the Republic of Mozambique understands that the global nature of climate change demands a true multilateral response, based on the principle of common but differentiated responsibility, where all countries should fully engage themselves for the future of our planet. We also understand that the Copenhagen Accord is a political instrument that will facilitate the ongoing negotiations within the Ad Hoc Working Group on Kyoto Protocol (AWG-KP) and Ad Hoc Working Group on Long Term Cooperative Action (AWG-LCA) with a view to reaching a successful conclusion.
