Welcome from Elena Espinosa , Minister of the Environment and Rural and Marine Affairs, Government of Spain

I would like to welcome all delegates participating in the Barcelona Climate Change Talks during the week of 2-6 November which aims to contribute to the success of the Copenhagen Conference.

Over 30 years ago the United Nations Conference on the Environment sounded the alarm with respect to the situation of the Earth and its resources. That historic event fostered the integration of the environment in sectorial policies, an irreversible process that has not been ignored by Spain.

The Barcelona Conference is the last stop prior to the Copenhagen Conference, which must produce a comprehensive and global agreement on how to mitigate climate change, adapt to its effects, facilitate access to technology and financial resources and provide an appropriate institutional response to manage all these aspects effectively in the medium and long term.

The road was mapped out in the Bali Action Plan. Following an intensive process by all governments to pool political wills the time has come now to adhere to the timetable. Urgent environmental issues require swift responses on our part but on this occasion the economic opportunity could not be greater: Copenhagen will help identify where to target major investment and technology development commitments and will also help restore market confidence. It is a crucial milestone and what seems difficult to us at present will soon seem obvious.

Agreement will only be possible if it is grounded on the principles of effectiveness, efficiency and equity. We need to lay the foundations for a fair and effective transition to the development model that will allow us to successfully address the requirements of the 21st century; one adapted to the limitations of our planet and to the legitimate aspirations of its inhabitants to enjoy adequate levels of wellbeing and development; one that reduces the economic and financial risks of a system that has so far proven incapable of integrating properly the very high costs it caused on its surroundings.

We need to move forward without delay. I therefore invite the participants – both the delegates as well as the representatives of civil society who will meet in the coming days in Barcelona – to work vigorously and in the belief that it is still possible to produce a significant and rapid change to a growth and development model that is kinder to the climate and offers greater solidarity to the most vulnerable citizens and nations.

It's an honour for our city to be hosting the *2009 Barcelona Climate Change Talks*. This year will be crucially important when it comes to making international commitments to carry out global and joint action against climate change. Welcome to Barcelona!

Welcome from Francesc Baltasar, Minister of Environment and Housing, Government of Catalonia

It is a pleasure and a great honour for me, as Minister for the Environment and Housing of the Government of Catalonia, to welcome you to Catalonia and the Barcelona Climate Change Talks.

Combating climate change has become one of the great challenges facing mankind in the twenty-first century. The scientific community tells us quite clearly that it is urgent and essential that we move against climate change. There can be no more debates about the need to act. Climate change is an unequivocal reality.

Now it is our turn, we have a responsibility to act, have a responsibility to do everything that must be done to face up to this challenge as the scientific community urges. Likewise, the agreement to be reached in Copenhagen will be the most complex global environmental treaty in history. We can see that, the distance we have covered since the Bali Action Plan has shown us how difficult it is to find common ground. But we will not lose hope; our responsibility is so great that we cannot fail.

Catalonia and Barcelona have been outstanding throughout history for being open to the world, a meeting place, a space for agreement, a land of welcome. I hope that the spirit of Catalonia and Barcelona affects us all and helps us, so that this week of talks may be useful and contribute to our reaching the best of agreements in Copenhagen.

As a Minister of the Government of Catalonia I cannot, nor do I wish, to miss the chance to remind you of the role we play, along with local governments, before the challenge of climate change. The agreements reached by the states will be developed, in part, by the other actors in government agencies and the private sector. Everyone has a fundamental role to play and many of the key policies for the effective reduction of greenhouse gas emissions in the areas of mobility, waste management, housing, industry or agriculture, amongst others, must be implemented on a regional and local scale. In adaptation policies the governments that are closest to the citizens will better understand the impact and will be better able to define the measures for adaptation. A territorial approach and subsequent rescaling of objectives is a guarantee of efficiency and will establish a framework of confidence and security for the transition towards a low-carbon economy.

In Catalonia, Government and society have assumed their responsibility. For this reason, in a concerted and coordinated manner, from the centre of government

we are developing a framework plan to reduce our emissions. This plan is consistent with Spain's commitments in the European sphere and aims to foster and execute measures for climate change mitigation that can and must be taken in Catalonia. We need a firm agreement in Copenhagen if we are to continue working in this direction. To continue developing structural measures for the transition to a low-carbon economy, beyond the current situation to which the economic crisis has led us and, as a central instrument to overcome it.

Authorities, delegates, ladies and gentlemen, welcome to Catalonia, it is pleasure to have you here. I hope you feel at home here and that this helps us to advance firmly in these talks. Copenhagen is close; Barcelona is the last stop. As I said before, now it's our turn, this is our responsibility. We must reach the best of agreements in Copenhagen.

Let us work well!

Where do I get my badge?

(e.g. passport, driver's licence, national ID card, work identity card) or a photo press card from the United Nations in Geneva, Nairobi, New York or Vienna. Press badges allow access to all public meetings and sessions unless indicated otherwise for security reasons.

Double registration for the informal meetings (e.g. simultaneously as a nominee of a Party and of an observer organization, or simultaneously as a nominee of a Party and as a press representative) is not permitted.






Fira Gran Via Hall 8

Barcelona is a safe city. Violent crime is rare. However, there are precautions that everyone should take to ensure that they do not become victims of accidents or petty crime. You should take your own security seriously and be aware of your surroundings. Most of it is common sense and could be followed anywhere in the world.

Taxis

Barcelona uses metered taxis, in which extra charges must be posted in the vehicle. Staff and participants are advised to use only clearly identified cabs and to ensure that taxi drivers always switch on the meter. A green light on the roof indicates that the taxi is available.

Cash and personal documents

Staff and participants are encouraged to carry limited cash, only one credit card, and a copy of their passport; leaving extra cash, extra credit cards, passports and personal documents in a safe location.

There is a requirement to provide proof of your identify if requested by a Police Officer. The only legally acceptable documents by Spanish Police are a passport or a national identification card. The Spanish Police have the right to hold you at a police station until your identity is confirmed. The Guardia Civil or Police will ask you to show them your documents only and do not request that you hand over your bag or wallet.

Safety and Security Services

The UN Security and Safety Service is working in close collaboration with the Spanish Government authorities to provide you a secure environment for your meeting. Our Officers, in United Nations blue uniforms or in civilian attire, are available to assist you with any problems you may have. Feel free to approach us if you have any security related concerns.

Please follow the instructions that UN Security Officers have give you, especially in relation to evacuation in case of fire.
