SUBMISSION BY THE EUROPEAN PARTNERSHIP FOR ENERGY AND THE ENVIRONMENT

The European Partnership for Energy and the Environment (EPEE), welcomes the opportunity to submit its views on the information aspects requested in Decision 17/CP.5 for information on available and potential ways and means of limiting emissions of hydrocarbons and perfluorocarbons, including their use as replacements for ozone depleting substance, taking into account, inter alia, health. medical, environmental and safety considerations, energy efficiency and associated emissions in carbon dioxide equivalent, and technical and economic considerations and as repeated in the Conclusions of the Chairman to the fifteenth session of the SBSTA.

The submission represents the views of the Partnership, which is a broad-based group of responsible companies, national associations and European associations active in the European air-conditioning, heat-pump and refrigeration industry. It was formed in September 2000 to contribute to the development of effective European policies to reduce greenhouse gases from the use of refrigerants.
