End of formal meetings:

no meetings beyond 6 pm (this is the 6 o'clock rule). There are various side events until 20:00. Some days there are also social events as receptions, check the DP for those, they are an excellent opportunity for networking!!



Ticketed meetings: for some meetings with limited access due to space constraints, tickets are provided to constituencies that, in turn, distribute to selected contituents.



Sustainability




